These indicate that a 23.90% Small Business Enterprise – Construction (SBE-Con) Subcontractor Goal is appropriate for this contract in the following trades: Highway, Street and Bridge Construction (Concrete work) – 16.84%, Painting and Wall Covering Contractors (Traffic Stripes and Marking) – 1.31% and Electrical Contractors and Other Wiring Installation Contractors (Lighting) – 5.75%
