Contractor shall furnish all failor, equipment, and materials required for the Heritage Park, maintaining the historic preservation requirements for the renovation and improvements. Including but not limited to: repair existing stone walls fence around Maintenance Building (MB) and Southeast Entrance; provide a concrete/masonry/oolite stone veneer and anodized aluminum perimeter fence; clean, repair and provide structural stabilization of existing stone incincrator while maintaining historical features; repairs to existing Rookery circle site stone work to restore stabilization to all components including overhook steps, repair mise existing sidewalks, walkways and provide accessible paths and accessible walkways; asphalt improvements, repairs and drainage; widen entranceway; beautification of the

Reasons for Recommendation

SMALL BUSINESS ENTERPRISE - CONSTRUCTION

An analysis of the factors contained in the project package, as well as the factors contained in Section VI.C. of Implementing Order 3-22 indicates that a 23.98% Small Business Enterprise – Construction (SBE-CONS) Subcontractor Goal is appropriate for this contract in the trades of: Site Preparation Contractors (Site work – 1.47%, Earthwork – 1.90% and Demolition – 0.87%) – 4.24%; Plumbing, Heating and Air-Conditioning Contractors (Plumbing – 1.48% and HVAC – 0.67%) – 2.15%; Electrical Contractors and Other Wiring Installation Contractors (Electrical work) – 3.91%; Poured Concrete Foundation and Structure Contractors (Concrete work) – 5.31% and All Other Specialty Trade Contractors (Asphalt Walkways Sidewalks/Parking Lot) – 8.37%. An attempt was made to make this project a Set-Aside and a Verification of Availability to Bid was sent to 322 SBE Cons certified firms; however, six (6) firms responded to the Verification of Availability to Bid process with only one (1) firm being able to meet the contract's requirements.
