Description of Project/Bid: The Contractor shall furnish all labor, equipment and materials required to comply with the intent of the work described in the contract documents for the RV Campground Facility upgrades including but not limited to: new lighting for Parking Lots and Roadway up to the park entrance

and main roads leading to the RV pods; new asphalt from main road to access roads leading to RV spaces; complete ADA improvements/upgrades to restroom/shower/laundry bldgs. #1,2,3 and 4; water service upgrade to pedestals; reconstruct areas; reconsolidate all trash enclosures; new one stop garbage station; replace entrance gate; new all-in-one RV pedestals; new sewer gravity main and lift station to serve the RV campgrounds and with further work identified in the contract

documents. This revenue/reservation facility project has special constraints due to phasing and

time constraints.

# SMALL BUSINESS ENTERPRISE – CONSTRUCTION (SBE-Con)

An analysis of the factors contained in the project package, as well as the factors contained in Section VI.C. of Implementing Order 3-22 indicates that a 11.18% Small Business Enterprise - Construction (SBE-Con) Subcontractor Goal is appropriate for this contract in the following trades: Site Preparation Contractors (Clearing, Grubbing, Demolition and Earthwork) – 3.27%, Poured Concrete Foundation and Structure Contractors (Concrete) – 4.22%, Painting and Wall Covering Contractors (Traffic Striping, Interior and Exterior Painting) - 1.37%, Tile and Terrazzo Contractors (Tile work) - 1.72% and All Other Specialty Trade Contractors (Fence and Gates) - 0.60%.

An attempt was made to make this project a Set-Aside, however of the six (6) firms that responded to the Verification of Availability process, none was able to meet the project's requirements.

### SMALL BUSINESS ENTERPRISE - SERVICES (SBE-Services)
