Provide water-service extension lines for on-site drinking fountains. Also, the coordination of water-works item(s) to be installed by the appropriate Jurisdiction. Provide a cage for each back-flow preventer; Row cul-de-sac swale and asphalt improvements; Provide new on-site P&D grading and drainage structures; Provide new electrical feeds for the irrigation system operation; Install new exterior mounting racks with cabinets for the installation of irrigation controls and rain sensor; Provide and install new drinking fountains; Extend plumbing lines for water supply (from new water-service), and the necessary sanitary plumbing lines discharging into civil drainage system; Install irrigation system in coordination with all construction sequences, to include: Irrigation rain/moisture sensors; also an irrigation timer placed secured within a lockable exterior cabinet and shall be mounted on an FPL rack; Install new concrete footers for playground equipment; Install playground equipment as required: Coordinate the high footer for the slide feature shall be an auger pile footer or similar configuration; Install complete sidewalk pathway system with perimeter curbing; Install multilayered engineered wood fiber (EWF) surface system as per manufacturers recommendation.
