Reasons for Recommendation

SMALL BUSINESS ENTERPRISE - ARCHITECTURAL & ENGINEERING (SBE/AE)

An analysis of the factors contained in the project package and Section V. C. of Implementing Order 3-32, and the responses of certified SBE/AE firms to the Verification of Availability to Propose process indicates that a 17.13% SBE/AE sub-consultant goal is appropriate. The A/E services estimated base amount is \$2,534,000.

SMALL BUSINESS ENTERPRISE - CONSTRUCTION

An analysis of the factors contained in Section VI. C. of Implementing Order 3-22 indicates that a 7.42% Small Business Enterprise - Construction (SBE-CONS) subcontractor goal is appropriate for the trades of: Electrical Contractors & Other Wiring Installation Contractors (1.84%-Electrical), Other Heavy & Civil Engineering Construction (1.42%-Site Civil), Commercial & Institutional Building Construction (3.33%-Gen. Bldg.), Water & Sewer Line Contractors (0.72%-Utilities), and Site Preparation Contractors (0.53%-Demolition)- 7.42%. The construction estimated base amount is \$36,009,000.

SMALL BUSINESS ENTERPRISE - GOODS & SERVICES

An analysis of the factors contained in Section VIII. B. of Implementing Order 3-41 indicates a 1.10% Small Business Enterprise - Goods & Services sub-contractor goal is also appropriate in the following commodities: Wrecking & Removal Services (0.54%)(96897), Coatings, Protective (0.02%)(31530), Coatings, Masonry (0.22%)(63009), Coatings, Protective, Asphalt Based (0.07%)(63012), Abrasives, Equipment & Tools (0.07%)(00505), Sod, Grass (0.06%)(79050), Electrical Equipment & Supplies (0.12%)(28500)- (1.10%).
