Design-Build services are required for approximately 2.14 miles of improvements running within Description of Project/Bid:

> or parallel to the County's Metrorail Right-of-Way that includes separate paved off-street bicycle and pedestrian paths, landscaping, lighting, street furniture, wayfinding signage, and pavement markings. Services will include, but are not limited to: civil design; landscaping design; electrical design; surveys; geotechnical; permitting; signage; public meetings; coordination of design with utility companies, the County, and the City of Miami; potential archaeological monitoring; environmental investigation remediation, and reporting; construction; compliance with grants and submittal requirements for the Florida Department of Transportation; and any ancillary tasks necessary to build the project and comply with the NEPA Category 1 exclusion

requirements. The Underline Project, once all phases are completed, will be a 10-mile linear

mobility corridor below the Metrorail.
