

This is a request for Review Committee (RC) approval of the proposed Community Small Business Enterprise (CSBE) goal in order to proceed with soil boring installation (drilling), sampling and reporting under the E14-RER-03 Professional Services Agreement for Project #002-D14/03-CBI, Soil Boring Installation, Sampling and Reporting at the BLDG 209 site, on behalf of the Miami-Dade Aviation Department (MDAD).

The subject project consists of the installation of 20 soil borings, sampling, and reporting. This contract, a work order originating from the E14-RER-03 Professional Services Agreement, has been assigned to CB&I Environmental & Infrastructure, Inc. (CBI).

The Department of Regulatory and Economic Resources, Division of Environmental Resources Management (DERM), RER staff has evaluated the project and recommends a 0.0% CSBE subcontractor goal for this project (please see attached Analysis for CSBE Goal Recommendation). At this time, DERM is not aware of any CSBE certified soil boring installation/drilling companies on the CSBE list. Therefore, DERM requests an exemption from the requirement to utilize CSBE subcontractors for this project. Please advise DERM in the event of availability of CSBE drilling companies.




