Background:

The project scope of work will consist of the modernization of numerous elevators on the Jackson Memorial Hospital Main, North and South Campuses in addition to the Long Term Care Center. The intent of the solicitation is to establish a pool of qualified elevator contractors to accomplish this. The elevators are manufactured by various manufacturers such as Armor, Eastern, Kone, Otis, and ThyssenKrupp. The elevator types to be modernized include hydraulic freight, passenger elevators, and dumbwaiters. There will be one new elevator installed in Park Plaza West with the possibility of additional units in the future. The modernization of the elevators will include replacement of the geared traction machines with gearless traction machines. The elevator contractor(s) shall include all scope of work required by other building contractors required for a complete turnkey project. The estimated cost for this project is \$8,600,000.00.

Minimum Requirements and Special Conditions:

Bidders shall provide evidence that the firm has actively and normally been engaged in the maintenance, service, repair and replacement of materials and equipment in elevators and/or escalators of the same manufacture, capacity and control systems as those covered by this contract, for at least the past ten (10) years. Bidders shall provide two (2) references of similar projects performed in the past three (3) years. Provide the contact information for a reference along with project details with the bid. Provide references with names, phone numbers and email addresses.

Each supervisor who will perform work under the contract shall have at the time of submission of bid a Certificate of Competency either as a Certified Elevator Technician or Certified Elevator Inspector, issued by Florida Department of Business Regulation, Division of Hotels and Restaurants, Bureau of Elevator Safety and shall renew it continuously. The bidder shall use only skilled, competent, trained elevator and/or escalator personnel having a minimum experience of three (3) years as an elevator and/or escalator mechanic in maintaining elevator and/or escalator systems similar to those in the specifications. The mechanic shall possess a current Certificate of Competency issued by the State of Florida, as a Certified Elevator Technician, or as a Certified Elevator Inspector as required by Florida Statute Chapter 399. Bidders must provide this information together with the bid response or immediately upon request by the Procurement Contracting Officer.

Availability:
