MIA Building 3030 1st Floor D Wing Tenant Relocation, MCC-AC007A

This is a request for approval of SBE/Construction contract measures recommendation for the MCC-9-18 Construction Management contractor to proceed with the required scope of work for the above referenced project. This work includes the demolition of existing area to proceed with the new work: New wall systems, doors, painting, new ceiling tiles and grid, lighting system and electrical work, network system, and sprinkler system for future office use of tenants.

The Contractor's staff has evaluated the project and suggests SBE/Construction set-aside packages as follows:

- Miscellaneous General Work Items (GC) (Pkg. "A"),
- Doors/Frames/Hardware (Pkg. "B"),
- Drywall (Pkg. "C"),
- Acoustical Ceilings (Pkg. D)
- Flooring (Pkg. E)
- Painting (Pkg. "F),
- Fire Sprinklers (Pkg. G),
- HVAC (Pkg. "H"),
- Electrical (Pkg. "I").

The suggested SBE/Construction subcontract items are listed on the Department Contract Measures Recommendation and Analysis form attached. This evaluation is based the Miami-Dade County SBE/Construction Certification List most current as of September 26, 2022.

Total suggested Small Business Enterprise/Construction trade set aside for this project is as follows:

\$ Trade Set-Aside = \$540,070.88 - Total Project = \$670,489.97

The MDAD Miscellaneous Construction Contract (MCC-9-18) requires that the General Contractor shall enter into subcontractor agreements to perform the work. Prior to the issuance of each Project Order Draft, or in the event of an emergency, as soon thereafter as practicable, per Ordinance 97-52, Miami Dade County will review each project for the establishment of contract measures relevant to Community Small Business Enterprise (SBE / CONSTRUCTION) participation in the work to be performed and will establish on each Project Order Draft as it is transmitted to the Contractor.

The MCC-9-18 Contractor will not enter into a subcontract agreement prior to receiving an executed Supplemental Authorization Order for each particular sub-project.
