An analysis of the factors contained in the project package, as well as the factors contained in Implementing Order 3-22 indicates a Small Business Enterprise-Construction (SBE/Cons) Trade Set-Aside is appropriate for the following packages: Package A - Commercial And Institutional Building Construction (Miscellaneous General Work) at 19.69%; Package B - Drywall and Insulation Contractors and (Drywall Work) at 22.81%; Package C -Painting And Wall Covering Contractors (Painting Work) at 10.97%; Package D - Plumbing, Heating, and Air-Conditioning Contractors (Fire Protection Work) at 5.42 %; Package E - Plumbing, Heating, and Air-Conditioning Contractors (Plumbing Work) at 13.63% and Package F -Electrical Contractors And Other Wiring Installation Contractors (Electrical Work) at 27.48%.
