An analysis of the factors contained in the project package, as well as the factors contained in Implementing Order 3-22 indicates a Small Business Enterprise-Construction (SBE/Cons) Trade Set-Aside is appropriate for the following packages: Package A - Commercial and Institutional Building Construction (Miscellaneous General Work) at 6.18%; Package B - Drywall and Insulation Contractors (Drywall Work) at 11.6%; Package C - Drywall and Insulation Contractors (Acoustical Ceiling Tile Work) at 4.7%; Package D - Flooring Contractors (Carpet Installation Work) at 1.25%; Package E -Finish Carpentry Contractors (Door Installation Work) at 6.85%; %; Package F - Glass and Glazing Contractors (Glass and Glazing work) at 2.08%; Package G - Painting and Wall Covering Contractors (Painting Work) at 3.16%; Package H - Plumbing, Heating, and Air-Conditioning Contractors (Fire Protection Work) at 5.9%; Package I - Plumbing, Heating, and Air-Conditioning Contractors (Plumbing Work) at 1.65%; Package J - Plumbing, Heating, and Air-Conditioning Contractors (HVAC Work) at 8.43% and Package K - Electrical Contractors and Other Wiring Installation Contractors (Electrical Work) at 48.17%.

The project estimated cost amount is \$675,400.04, the total suggested SBE/Cons is \$568,729.49 (84.21%) of the total project estimated cost, Allowance Account and MCC Fee \$106,671.00 (15.79%) of total project cost.
