SBD is conducting a survey of <u>Terrazzo Flooring Contractors</u> in order to stablish sufficient availability of contractors under <u>MCC 7040 Contract</u> for <u>Miami Dade AVIATION Department</u>. If you are interested in participating on this contract, and meet the requirements, <u>please reply to this email IMMEDIATELY</u>; <u>Wednesday at 12:00 Noon the latest</u>.

**SCOPE:** The scope of work for this project includes the maintenance, repair and/or full replacement of damaged Terrazzo flooring and MDAD facilities.

Due to the special operational conditions the contractors shall be required to:

- Contractor must have minimum 5 years verifiable experience installing Cementitious and Epoxy Terrazzo, and Prefabricated Epoxy Terrazzo Panels.
- Contractor must be able to provide a list and brief description of at least 3 completed projects of similar scope of work, size and complexity.
- Submit the Performance & Payment bond in the amount of the entire contract allocation of \$500,000.00.
- Contractor, its employees, its subcontractors and suppliers shall comply with all MDAD security requirements including background checks, security badges, identification badging bonding requirements, specialized aviation-related insurance requirements, etc. therefore a valid MDAD identification (ID) badges with a Customs Seal will be required for all personnel working on MDAD facilities, as well as vehicle permits to enter airside (with accompanying insurance).
- Comply with the INDEMNIFICATION AND INSURANCE requirements as follow::
- The Contractor shall furnish to the Miami-Dade Aviation Department (MDAD) located at Miami International Airport (MIA) Bldg. 3030. 4331 N.W. 22nd Street, Miami, Florida 33159, Certificate(s) of Insurance which indicate that insurance coverage has been obtained which meets the requirements as outlined below:
  - A. Worker's Compensation Insurance for all employees of the Contractor as required by Florida Statute 440.

- B. Commercial General Liability Insurance including Products and Completed Operations in an amount of not less than \$1,000,000 combined single limit per occurrence for bodily injury and property damage. Miami Dade County must be shown as an additional insured with respect to this coverage.
- C. Automobile Liability Insurance covering all owned, non-owned and hired vehicles used in connection with the work, in an amount not less than \*\$1,000,000 combined single limit per occurrence for bodily injury and property damage.

\*Under no circumstances are Contractors permitted on the Aviation Department, Aircraft Operating Airside (A.O.A) at Miami International Airport without increasing automobile coverage to \$5 million (\$5,000,000.00). Only vehicles owned or leased by a company will be authorized. Vehicles owned by individuals will not be authorized. \$1 million limit applies at all other airports.

All insurance policies required above shall be issued by companies authorized to do business under the laws of the State of Florida, with the following qualifications:

The company must be rated no less than "A-" as to management, and no less than "Class VII" as to financial strength by Best's Insurance Guide, published by A.M. Best Company, Oldwick, New Jersey, or its equivalent, subject to the approval of the County Risk Management Division.

The company must hold a valid Florida Certificate of Authority as shown in the latest "List of All Insurance Companies Authorized or Approved to Do Business in Florida" issued by the State of Florida, Department of Financial Services.
