Work of this project is comprised of the repair and restoration of the Alexander Orr Jr. Water Plant Historic Mural of the Reflecting Pool. The Mural constructed in 1953 primarily of cast concrete, depicts Everglades wildlife and fauna. Portions of the mural have broken free from the panel and fallen into adjoining reflecting pool.
