**DESCRIPTION OF PROJECT:**

The project consists of dewatering a portion of the existing 96-inch raw water main to facilitate construction, and removal of three (3) 20-foot sections of existing 96-inch PCCP raw water main along West 11<sup>th</sup> Street in the City of Hialeah. The Contractor shall furnish and install a 96-inch butterfly valve and two (2) access manholes, one on either side of the valve. Additionally, the contractor shall coordinate with Pure Technologies to disconnect the AFO cable prior to the start of construction and reconnect the AFO cable after construction is completed. The contractor shall also furnish and install a 2-inch corporation stop on both the access manway blind flanges and connect them with a 4-inch PVC pipe (Schedule 80).

**LICENSES:** The types of licenses required are: General Engineering Contractor, State Underground Contractor, Pipeline and/or other categories as applicable by Chapter 489 of the Florida Statutes or Chapter 10 of Miami-Dade County Code.

**CWP PARTICIPATION: Is not Applicable, project is not located in a DTA.**

**MINIMUM EXPERIENCE REQUIREMENTS:**

In addition to the license requirement, the bidder must have three (3) years of experience under its current name (which can include the experience of key supervisory employees that would man the project), in the construction of projects of similar scope; supported by references for three (3) projects completed within the past ten (1) years. Submitted reference projects must demonstrate that the Bidder served as the Prime Contractor for the referenced project. Qualifying projects shall demonstrate:

- a) The Bidder's experience removing and replacing PCCP and valves 48-inches and larger.
- b) The Bidder's experience working in confined spaces
