SCOPE OF WORK/DESCRIPTION: The scope of work includes but is not limited to maintenance dredging of unvegetated bottom sediment at boat slip on the North One Pier of Crandon Park Marina, to a uniform maximum depth of five (-5) feet below Mean Low Water (MLW). CONTRACTOR shall dredge, remove, and dispose of the final amount (irrespective of quantity) to achieve the targeted depth within the targeted area. Removal and disposal of existing chain link fence in tidal waters. Installation and preparation for turbidity control curtains during entire duration of the work as indicated on construction drawings and on turbidity control and dredge spoil disposal plan letter. Notice that dredge spoil should be left to dry out, transported and spread within Crandon Park (exact areas will be determined during construction) Relocate existing decorative stones to facilitate circulation at job site. Stones should be safely stored and placed at same original location at completion of work. Temporarily remove security chain link fence at edge of seawall only to the extension necessary for dredging activities. Removal of existing landscape material in order to access area of work and additional work as specified in the contract documents.
