The Department of Transportation and Public Works (DTPW) is forwarding this memorandum to the Miami-Dade County (County) Internal Services Department's Division of Small Business Development for informational purposes regarding the referenced state and local funded project. The DTPW's Office of Civil Rights (OCR) has analyzed the Department's workload based on anticipated projects' scope of work, cost estimate, and technical certifications. As a result, the OCR has assigned a race-neutral aspirational Disadvantaged Business Enterprise Goal of 10.65 percent to be applied to the Project. Davis Bacon Wages and Responsible Wages and Benefits for Heavy and Building are applicable to this Project.

Scope of Services - DTPW has a need to establish construction services for the project entitled: "Park & Ride Lot at SW 112 Avenue and SW 204 Street Busway (the "Project"). The Project in general, consists of the rehabilitation of the existing Park and Ride Lot at SW 112 Ave and SW 204 Street Busway to accommodate approximately 450 parking spaces. The work includes but is not limited to, furnishing all supervision, labor, materials, equipment, tools, services, and incidentals necessary for milling, resurfacing of the Park and Ride, minor widening of the pavement, construction of new sidewalks, upgrades to existing pedestrian ramps and crosswalks, replacement of damaged curbs, signing and pavement markings associated with the new configuration of the Park and Ride, parking bumpers lighting upgrades, installation of passenger shelters and sodding in compliance with the latest Florida Department of Transportation (FDOT) Design Standards.

The total estimated fee for construction services is \$967,102.68, which includes a base amount of \$861,002.44, a ten percent contingency allowance account for unforeseen services, of 86,100.24, and a dedicated allowance account for Permits of \$20,000.00. The funding source for the project is FDOT and People's Transportation Plan Bond Program. The Prime Contractor must hold a current State of Florida General Contractor's License and have a minimum of five years of experience or completed three projects of similar scope.
