SCOPE OF WORK/DESCRIPTION: Within the past several months, various fire stations have submitted service requests for water intrusion and mold related damages. In addition, exposure reports have been filed by MDFR station personnel that range from allergic illnesses to toxic effects and everywhere in-between. MDFR has been work ing diligently to address and mitigate these issues under an emergency declared by Chief Downey. However, we are now moving away from the emergency and would like to establish a permanent mechanism in place to address these issues when they arise so that they do not become an emergency.

It is important to note that fire stations are a 24-hour, 365 day/year operation which service the residents of Miami Dade County. Maintaining these stations operational with minimum disruption to staff and the community is of the utmost importance. Thererfore, tackling this issue at the inception is key to minimizing illnesses while maintaining the level of service the residents of Miami Dade County have come to expect.

- Institute of Inspection Cleaning and Restoration Certificate -OR- equivalent certification by an organization that adheres to the same globally recognized standards for the assessment, inspection cleaning and restoration established by the industry
