CONTRACT TITLE: One-Year Countywide Contract for Restoration of Sidewalk, Curb, Gutters and Driveways with County Option to Renew for an Additional Two Years on a Yearly Basis

DESCRIPTION OF PROJECT:

The Project consists of furnishing all materials, labor, and equipment necessary for restoration of sidewalks, curb and gutters and driveways under different Work Orders at different locations anywhere within the limits of Miami-Dade County, Florida, as ordered by the Department during a one year period. This is a non-exclusive contract, and as such, the Department does not guarantee that the full amount of the Contract will be issued to the Contractor. The actual amount of Work Orders assigned will be the prerogative of the Department in its sole discretion and dependent only upon its needs.

The work includes: the removal and restoration of existing sidewalks, curb and gutters and driveways to include saw cut joints, excavating and removal of existing concrete or asphalt; removal of any tree roots and debris; legally disposing of all demolition debris and removed materials including paying all applicable tipping fees; placing and compacting backfill; forming, pouring and finishing new concrete; furnishing and installing colored wear resistant finished were required; resetting of existing meter box if necessary; constructing pedestrian curb ramps with detectable warning; constructing new sidewalk, curb and gutters and driveways.

The unit prices bid will be used for uniform comparison among the bidders, and the bids will be evaluated based upon the lowest total amount bid in the Proposal. The Contract will be awarded for an aggregate amount of up to Two Hundred Fifty Thousand Dollars (\$250,000.00) for a twelve month period. Unless the Contract is extended, it will terminate upon the depletion of the Two Hundred Fifty Thousand Dollars (\$250,000.00), or the expiration of the 12 month period, whichever occurs first. The County Major or his designee has the option to renew the Contract for up to an additional two years and the Contractor shall maintain the same prices, etc. used in the original contract. Each renewal option will be for a one-year period and up to \$250,000.00.
