This Pygmy Hippo animal containment project scope is for the Contractor to furnish all labor, equipment and materials required to comply with the intent of the work described in the contract documents including but not limited to: Install all fencing, caging, gates, footers, and retaining wall for the Pygmy Hippo Enclosure. All work will be completed per plans and specifications. Provide shop drawings as requested by Architect of Record.

Estimated Total Cost: \$243,250.00

Miami-Dade County Parks, Recreation and Open Spaces Department (PROS) is requesting that the General Contractor be in business at least five years, having completed animal containment projects similar in size and scope to the subject project.

Due to the specific nature in the scope of the work involved, PROS respectfully requests that SBD considers a 2.2% SBE-Cons for an Electrical contractor **or** <u>no measure</u>. PROS' believes that the Electrical sub-trade can be performed by SBE Construction single trade firms without the required experience. The rest of the work will be required the experience detailed above. An analysis of the CSBE Program Ordinance 97-52 as amended, and I.O 3-22 has been conducted and requests use of the 7360 Contract to ensure sufficient participation of Contractors experienced with specialty animal containment installation.
