SCOPE OF WORK:

- Develop integration solution to expand capabilities of existing Digital Signage Content, Author, and Player Software as follows:
 - Enhance existing integration digital signage players without interfering with current status and network monitoring of playback systems, content reporting tools for ledger reconciliation, including real time task lists;
 - Eliminate the requirement for individual content player to directly access data source systems;
 - Add a communication layer between the data source and the Visual Communication device that will allow the management of server traffic and translate from native APIs to ingestible data;
 - Provide configurable, pre-built apps, templates, and plug-ins to update the visual communications network;
 - Provide all necessary adapters; and
