**PROJECT DESCRIPTION:** End-of-Life replacement of existing Strands SL lights with Philips Strand Lighting Selecon SPX LED profile fixtures

### APPROXIMATE PROJECT COST:

### **SCOPE OF WORK:**

- Removal of approximately one-hundred and thirty (130) existing Strand SL lights.
- Vendor must furnish following Bill of Materials:
  - o (130) Philips Strand Lighting Selecon SPX LED Profile lamps
- Installation of Philips Strand Lighting Selecon SPX LED profile spotlight engine with tube adaptor and mix cables.
- Equipment solution must include installation of lens tubes, C-clamps, power connectors, and programming for direct DMX wire controllability.
