- Bolt washers to existing concrete foundation.
- Position and level dryers and/or ironers.
- Connect equipment to existing utility lines.
- Disposal of existing machines.
- Set-up, support, testing and in-service training.

TIMELINE:

- Procurement of materials and installation must be completed within one (2) week of vendor approval.
