Modification No. 1 under BW-10291, JMS Consultant Services to provide additional expenditure authority in the amount of \$2,500,000 (\$250,000 in additional expenditure authority and approval to exercise all option-to-renew terms with \$500,000 per term) and to approve the exercising of the four, one-year renewal options under the contract. BW-10291 established a contract with GTEL Advisors, LLC for project management support, business analysis services, quality assurance, and subject matter expertise for procurement and implementation of a new "Jail Management System" or JMS for the Miami-Dade County Corrections and Rehabilitation Department. Specific tasks and activities will be assigned by and at the direction of the Project Manager and may include, but are not limited to evaluating, managing, procuring, or implementing informational and technical systems within Miami-Dade Corrections and Rehabilitation department (MDCR).

There were fifty nine (59) SBE firms certified in the commodity codes below at the time this modification request was reviewed.
