SECTION 2

SPECIAL TERMS AND CONDITIONS

2.1 PURPOSE

This Request to Qualify (RTQ) will be used to establish a prequalified Pool of Vendors (Pool) that may be used for the removal of private vehicles and/or boats parked without authorization or abandoned on property owned or controlled by Miami-Dade County (County). Placement in the Pool is not a contract between the County and the Vendor, but an acknowledgement that the Vendor meets the qualifications and requirements outlined throughout this RTQ. Vendor Submittals will be accepted throughout the term of the RTQ for placement in such Pool.

2.2 DEFINITIONS

Abandoned Vehicles – shall refer to, but not be limited to, automobiles (all types of sedans, pick-up trucks, vans), all types of heavy trucks, all types of golf carts, ATV's, UTV's, etc., that are left behind for an extended period of time, as determined at the County's sole discretion.

Complete Submittal – shall refer to a submittal that meets all solicitation qualifications and requirements, includes all necessary documents, and is from a Vendor that meets the minimum standards of business competence, financial ability, and/or product quality. Only complete submittals may be considered for placement in a Pool.

Incomplete Submittal – shall refer to a submittal that does not meet all solicitation qualifications and requirements, or does not include all necessary documents, or is from a Vendor that does not meet the minimum standards of business competence, financial ability, and/or product quality.

Prequalified Pool of Vendors (Pool) – Shall refer to business entities/individuals determined by the County's Internal Services Department, Strategic Procurement Division, as meeting the minimum standards of business competence, financial ability, and/or product quality for placement in the Pool, and which may submit quote or proposal, at the time of need.

Registered Vendor – shall mean a firm that has completed the Miami-Dade County Business Entity Registration process via the County's online Vendor Portal (<http://www.miamidade.gov/procurement/Vendor-registration.asp>) and has satisfied all requirements to enter into business agreements with the County. Vendor shall be a Registered Vendor to be considered for placement in this Pool.

Request to Qualify (RTQ) – shall refer to this solicitation, which is used to establish a Pool.

Vendor – Shall refer to a business entity/individual responding to this RTQ.

Service Location – Shall refer to the location where signs will be installed for towing services, within any subzone, and assigned to a prequalified vendor.

Subzone – Shall refer to the designated area under the North or South zone that will encompass a perimeter that contains multiple service locations within it.

Submittal – Shall refer to all information, attachments and forms submitted in response to this RTQ.

Unauthorized Parked Vehicles – shall refer to, but not be limited to, automobiles (all types of sedans, pick-up trucks, vans), all types of heavy trucks, all types of golf carts, ATV's, UTV's, etc., that are improperly or unlawfully parked on County property, and/or afterhours, as determined at the County's sole discretion.

Zone – Shall refer to the perimeters of the North and South zones as geographically separated by Kendall Drive. Each zone contains a set of subzones within it and each subzone contains several service locations within it.

2.3 TERM

The Pool shall be established on the first calendar day of the month succeeding approval by the Board of County Commissioners, or designee, unless otherwise stipulated in the Purchase Order issued by the Internal Services Department, Strategic Procurement Division. The Pool shall expire on the last day of the five-year term.

2.4 METHOD OF AWARD (Group by Group Basis)

Establishment of and prequalification under this pool will be made to all responding Vendors who meet the following qualification criteria as evidenced by submission of the documentation listed below, in order to participate in future requests for information or similar from County departments.

During the term of this RTQ, the County reserves the right to add additional Vendors or remove any previously prequalified Vendors, as it deems necessary, at its sole discretion and in its best interest. During the evaluation period, the County reserves the right to not prequalify any vendors, at its sole discretion and in its best interest.

Vendors may participate in any or all of the following groups:

- Group 1:** North Zone, Subzone 1
- Group 2:** North Zone, Subzone 2
- Group 3:** North Zone, Subzone 3
- Group 4:** North Zone, Subzone 4
- Group 5:** South Zone, Subzone 5
- Group 6:** South Zone, Subzone 6
- Group 7:** South Zone, Subzone 7
- Group 8:** South Zone, Subzone 8

2.5 QUALIFICATION CRITERIA

Vendors shall be Miami-Dade County Registered Vendors and meet the following qualifications and requirements to be considered for placement in the Pool.

2.5.1 Submittal Requirements

1. Vendors shall provide a **copy of a current towing license (TL)**, in accordance with the Code of Miami-Dade County, Florida Section 10-3 (B). Vendor's license must be registered as "non-consent" and issued by the Miami-Dade County Department of Regulatory and Economic

Resources (RER), as of the proposal due date. Prequalified Vendors towing license shall remain valid during the term of the Pool to include any option to renew period(s). The license provided must be in full force effect at the time of submittal due date. Failure to meet the requirement may result in your submittal being rejected.

2. Vendor shall provide **either contact information for two references, or two signed professional references** on the referenced company's letterhead, to demonstrate that Vendor is regularly engaged in the business of providing towing services for customers, governmental agencies, or similar. In lieu of the references from the Vendor or Vendor's Subcontractor, the County will consider the references from Vendor's key personnel in accordance with Resolution No. 1122-21. The County must be able to ascertain from Vendor provided references, to its satisfaction, at the County's sole discretion, that Vendor holds sufficient experience and capacity in providing towing services.
3. The Vendor shall provide the contact information for a representative(s) authorized to discuss matters pertaining to the contracted services, who can provide pertinent information and who are cognizant of the industry and industry standards. To satisfy this requirement please provide contact name, telephone number(s), email addresses, and/or fax numbers of available staff that may be contacted 24/7.
4. Vendors shall submit a complete inventory list of towing equipment operated by their company, as listed in section 3. This list shall show the vehicle's year of manufacture, Gross Vehicle Weight Rating (GVWR), class of operation, VIN, license tag number, and registered owner.

This list shall be in agreement with the equipment list of units holding valid tow truck decals and tow truck inspection reports on file with the Consumer Services Division with Department of Regulatory and Economic Resources (RER) at the time of submittal due date. This list shall show the vehicle's year of manufacture, class of operation, serial number, license tag number, registered owner, and permit decal issued by the County.

5. If the registered owner of the vehicle is not the Vendor, the vehicle shall be under lease or contracted to the Vendor and a copy of such contract must be on file with the Consumer Services Division under the Department of Regulatory and Economic Resources (RER) at the time of submittal due date and may be requested for review of authenticity by Miami-Dade County's Strategic Procurement Division. If such contract is not in full force and effect prior to the submittal due date of this solicitation, that vehicle may not be counted on the equipment list towards satisfaction of the minimum equipment requirements.

As proof of compliance with the requirements of this RTQ, Vendors shall provide all of the specified information, documents and attachments listed above with their Submittal. However the County may, at its sole discretion and in its best interest, allow Vendors to complete, supplement or supply the required documents during the evaluation period. It shall be the sole right of the County to determine the number of Vendors which will be included in the Pool.

2.6 ADDITIONAL REQUIREMENTS

As of the submittal due date, the principal(s) of a Vendor shall not be a principal of another Vendor (to include any real property owned, leased property, or equipment used to qualify). Additionally, no Vendor shall have any sort of ownership or be a stockholder of another Vendor.

Vendors shall not subcontract with other Vendors. Vendors shall not use equipment, property or facilities of another Vendor to qualify under this Pool or to meet its contractual obligations after prequalification.

All requirements herein are a continuing condition of prequalification and are in effect throughout the term of this Pool. A violation of these requirements may cause the Vendor's submittal to be deemed non-responsive or cause the removal of a selected Vendor(s) from the pool.

2.7 PAYMENT

Payment for services rendered will be made by the registered owner of the vehicle. Miami-Dade County nor any of its employees, agents, or officers working on this contract shall be responsible for any payments, fees, or charges incurred under this Pool.

2.8 PRICES AND FEES

The prices, rates, or fees charged by the Vendor shall be due to the owner or operator of the vehicle towed.

All prices, rates, and fees charged by the Vendor must comply with the rates and fee schedules established in Miami-Dade County Ordinance Sec. 30-476, as applicable to the Miami-Dade County's Maximum Non-Consent Towing Rates found in the following link: <https://www.miamidade.gov/business/library/fees/towing-max-non-consent.pdf>.

Such prices, rates and fees are with exception where municipalities have established differing maximum rates for their jurisdictions, pursuant to Sections Statutes.

In accordance to Sections 713.78(2), 125.0103 and 166.043, Florida

Florida Statutes and Sec. 30-476, Miami-Dade County Ordinance regarding storage of the vehicles, as well as in regards to the fees to be charged, the Vendor is not to exceed fees imposed on the vehicle owner, nor shall a storage fee be charged if the vehicle is stored for less than six (6) hours.

2.9 LOCATIONS MAY BE ADDED OR DELETED

Although this solicitation and resultant prequalification Pool identifies specific service locations within the subzones in need of towing services, it is hereby agreed and understood that any County department may, at their discretion, add or remove service locations as necessary.

2.10 INSURANCE REQUIREMENTS

Below is a list of insurance requirements for informational purposes. County Departments will include insurance requirements in future Requests for Information, or similar request.

Section 1.22 Insurance Requirements of the General Terms and Conditions, Subsections B and C are superseded and replaced in their entirety.

- A. Worker's Compensation Insurance for all employees of the Vendor as required by Florida Statute 440.
- B. General Liability Insurance including Garage Keepers Legal Liability in amount not less than \$500,000 combined single limit per occurrence for bodily injury and property damage. Miami-Dade County must be shown as an additional insured with respect to this coverage.
- C. Automobile Liability Insurance covering all owned, non-owned and hired vehicles used in connection with the work, in an amount not less than \$500,000 combined single limit per occurrence for bodily injury and property damage.

SECTION 3

SCOPE OF WORK/TECHNICAL SPECIFICATIONS

3.1 SCOPE OF WORK

This Pool shall be used to remove unauthorized and/or abandoned property/vehicles from property owned or controlled by Miami-Dade County for multiple County departments, on an “as needed basis”.

No County marked vehicle, or vehicles with a yellow County license plate shall be towed under this pool.

It is the intent of the County to assign no more than one Vendor per service location. However, a vendor can be assigned multiple service locations.

3.2 ZONE DISTRIBUTION

The service locations under each subzone are included for informational purposes in *Attachment A, Subzones and Service Locations*. *Attachment A* may include, but not limited to its contents, and may be augmented at the time of Requests for Information, or similar request by County departments.

The County is divided into two (2) zones. The North Zone includes Subzones 1 – 4 and the South Zone includes Subzones 5 – 8.

North Zone	Subzone 1:	Area West of 32nd Avenue from NW 36 Street North to the County Line, to include into Broward County as needed.
	Subzone 2:	Area East of 32nd Avenue to the Ocean, from NW 36 Street (41st Street on Miami Beach) North to the County Line, to include into Broward County as needed.
	Subzone 3:	Area South of NW 36 Street, South to Kendall Drive (SW 88th Street) West of the Palmetto Expressway to the West Boundary of the County.
	Subzone 4:	Area from NW 36 Street (41st on Miami Beach) South to Kendall Drive (SW 88 Street), Palmetto Expressway East to the Ocean.
South Zone	Subzone 5:	Area from Kendall Drive (SW 88 Street) - South to SW 184 Street, West of SW 117 Avenue, West to the Western Boundary of the County.
	Subzone 6:	Area from Kendall Drive (SW 88 Street), South to SW 184 Street, from SW 117 Avenue, East to the Ocean.
	Subzone 7:	Area from SW 184 Street and Krome Avenue, extending to the County Line West and South.
	Subzone 8:	Area from SW 184 Street and Krome Avenue, extending to the County boundaries East and South.

3.3 WARNING SIGNS AND NOTICES

All signs posted by the County or the Vendor shall adhere to Florida Statutes: <https://www.flsenate.gov/Laws/Statutes/2011/715.07>

- A. Upon receiving the list of service locations to be serviced and under the direction of the County, Vendors may be required to remove signs not belonging to them and shall subsequently provide, install, and maintain warning signs on the County property or facility. The Vendor shall provide these signs and notices at no cost to Miami-Dade County.

- B. All warning signs and notices posted by the Vendor on County property must conform to the requirements of the Towing Ordinance and all applicable Miami-Dade Building Code standards.
- C. **For Signs Installed by County Departments:** If Vendors do not provide signs to the requesting County department within the time specified at the time of Requests for Information for assignment of service locations, staff may then go to the next available Vendor within that subzone capable of providing signs, as directed by department staff, at the County's sole discretion and in its best interest.
- D. **For Signs Installed by the Vendors:** If Vendors do not provide and install signs for the requesting County department within the time specified at the time of Requests for Information for assignment of service locations, department staff may then go to the next available Vendor within that subzone capable of providing and installing signs, as directed by department staff, at the County's sole discretion and in its best interest.

3.4 LIST OF SATISFACTORY EQUIPMENT:

The list of equipment below is not all inclusive, and more or less equipment may be required, as contingent upon the nature and needs of the tow required.

WRECKERS (for applicable tows):

All wreckers shall be maintained in good working order, completely hydraulic, shall be registered with the State of Florida Department of Motor Vehicles and shall have appropriate licenses to operate as wreckers. The registration must reflect as the company or corporation prequalified to this Pool, unless otherwise stated in section 2.4.1.4(b).

- A. Prequalified vendors shall maintain the following minimum number of vehicles (selected Vendors may substitute a vehicle one (1) class and type higher than that required, i.e., Class "B" slide back for a Class "A" slide back):

- 1. Six (6) Class "A" Wreckers
(At least two (2) shall be Class "A" Wreckers and two (2) shall be Class "A" Slide Back Car Carriers)

NOTE: The prequalified Vendors for Zones 5, 6, 7 or 8 (Northside/Bay Operations/Miami International Airport) shall have a minimum of one (1) Class "A" vehicle which can clear an overhead height of 6 feet, 6 inches and must meet same requirements as a Class "A" Wrecker.

- 2. One (1) Class "B" Wrecker
- 3. One (1) Class "B" Slide Back Car Carrier

- B. Wreckers shall meet the following minimum ratings:

In accordance with Article III Section 30-461 - Definitions. (22) Wrecker class shall mean the type of towing vehicle, equipment or apparatus used to recover, tow or remove vehicles. If there has been any modifications to the truck chassis that changes its GVWR, documentation from the dealer, manufacturer or authorized up-fitters supporting the changes must be provided. The wrecker class shall be distinguished as follows:

- 1. **Class "A" Wrecker**
- 2. **Class "A" Slide Back Car Carrier**
- 3. **Class "A" Slide Back Car Carrier**
