SECTION 2: SPECIAL TERMS AND CONDITIONS

2.1 PURPOSE

The purpose of this solicitation is to establish a contract for the lease of golf carts and utility vehicles, inclusive of short term rentals, for the Parks, Recreation, and Open Spaces Department (PROS).

2.2 GROUPS

This solicitation shall include the following three Groups:

- 1) Group 1 - Golf: Shall include carts and/or utility vehicles used at all County-operated Golf Courses
- 2) Group 2 - Parks: Shall include carts and/or utility vehicles used at all County-operated Parks
- 3) Group 3 - Zoo: Shall include carts and/or utility vehicles used at Zoo Miami

2.3 TERM OF CONTRACT

This Contract shall commence on the first calendar day of the month succeeding approval of the Contract by the Board of County Commissioners, or designee, unless otherwise stipulated in the Purchase Order issued by the Internal Services Department, Strategic Procurement Division. The Contract shall expire on the last day of the 36th month.

2.4 OPTION TO RENEW

Prior to, or upon completion of the initial term, the County, at its sole discretion, reserves the right to exercise the option to renew this Contract for one (1) additional **three (3) year term**. **The awarded bidder shall provide proof indicating they are able to supply all the carts required for three (3) additional years, prior to the County exercising the option to renew.**

2.5 METHOD OF AWARD

Award of this contract will be made on a group basis, (Golf, Parks, and Zoo), to at least two (2) responsive and responsible Bidders, who have met the bid submittal requirements detailed in Section 2.5, and whose offer represents the lowest, and second lowest price, for the 36 month lease rate in the aggregate of each group as follows:

Estimated Quantity X Monthly Rate for 36 Month Lease = Line Item Sum
Add all Line Item Sums within a Group = Group Aggregate

New: Failure to provide a 36 month lease rate/offer for all the items listed, its overall offer may be deemed non-responsive, and ineligible for Award.

2.5.1. Daily, Weekly, Month to Month, 12-month, and 24-month rates on the Pricing Sheet in Section 4.1, are optional short term leases, and pricing submitted for these options will not be used to determine the lowest bidder for the group. However, when needed the optional, short term leases would be contracted from the awarded Bidder for each group. If an awarded Bidder does not provide pricing for the short term options with its bid submittal, the County reserves the right to contract the short term options with the other awarded Bidder within the group.

2.6 BID SUBMITTAL REQUIREMENTS

To be eligible for award recommendation, Bidders must submit the documentation requested below. Failure to meet the bid submittal requirements may result in the Bidder not being recommended for award. Bidders may be given the opportunity to provide the required documentation during the bid evaluation period, at the County's discretion.

- 2.6.1. Bidder shall be regularly engaged in the business of providing golf cart and utility vehicle rentals and/or leases to government agencies and/or private corporations on a similar scale. Bidder shall submit either two (2) signed professional reference letters on the referenced company's letterhead, or two (2) different Commercial Business and/or Governmental Agency references to demonstrate that the Bidder/Key personnel is currently providing or has provided goods and services within the past two (2) years similar to what is described in this solicitation (Section 4: Vendor References). The references should include the customer's company name, length of business relationship, and the name, title, address, email address and telephone number of the contact person providing the reference. In lieu of the references from the Bidder, the County will consider the references from Bidder's key personnel in accordance with Resolution No. 1122-21.
- 2.6.2. Bidder shall provide the contact information of a designated representative to provide the County with information and support concerning the contract. Bidder shall provide the representative's name, title, phone number, and email address.
- 2.6.3. Bidder shall complete the Bid Submittal Form in Section 4.0, and submit their offer on the Pricing Sheets in Sections 4.1. Do not include any additional documents with your bid submittal and pricing sheets.

2.7 PRICES

Golf cart and utility vehicle pricing shall be based on the current production model year, and include freight, delivery, maintenance, parts, repairs, loaners, and return transportation cost. The Bidder's price per line item, and term, shall be inclusive of all fees and costs. **Additional charges, fees or assessments will not be authorized.** Pricing shall remain fixed and firm for the three (3) year contract term.

Ninety days prior to the start of the Option to Renew term (if exercised), the County may consider an adjustment to prices, upward or downward, based on the most recent **Producer Price Index (PPI), Commodities, Rental and Leasing of Goods**. It is the Awarded Bidder's responsibility to request any pricing adjustment under this provision. If the Awarded Bidder does not submit a request in writing, the County will assume the Awarded Bidder agrees to maintain the current contract prices for the renewal term. The County reserves the right to reject the adjustment request at its sole discretion, and this decision shall be final.

Any and all price adjustments authorized by the County shall be made in the form of a Contract Modification signed by the Awarded Bidder. Under no circumstances should the Awarded Bidder invoice the County a price that is higher than the price authorized through the original contract award or an approved Contract Modification.

2.8 ADDITIONAL CARTS / OPTIONAL ITEMS

While the County has listed its most commonly used golf carts and utility vehicles within this solicitation, there may be other items needed during the term of this contract. Under those circumstances, a County representative will contact the Awarded Bidder to obtain a price quote for the specific cart, utility vehicle, and/or additional, or optional items, and/or for optional lease terms. Additional and/or optional items may include, but are not limited to the following, chassis undercoating to protect against rust, GPS, tops, windshields, sand buckets, cages, cart coolers, bag covers, rain guards, premium beverage carts, message holders, and USB ports. If needed, these one-off additions will be incorporated into the contract via a Contract Modification, to be executed by the Awarded Bidder.

2.9 INSURANCE

The Awarded Bidder shall submit proof of insurance as required per Section 1.22 of the County's General Terms and Conditions. The following requirement replaces the standard coverage in Section 1.22.A.2.

A.2. Commercial General Liability in an amount not less than \$1,000,000 per occurrence \$2,000,000 in the aggregate including products/completed operations.

SECTION 3: SCOPE OF WORK AND SPECIFICATIONS

3.1 SCOPE OF WORK

The Awarded Bidder shall provide the leasing of golf carts and utility vehicles, inclusive of short term rentals, to the Parks, Recreation and Open Spaces Department, under the following Groups: Golf, Parks, and Zoo. All carts and utility vehicles quoted and offered shall be the most current production model year manufactured; be fully functional, operational, performing and appearing in new condition. Each cart and utility vehicle shall have the required minimum specifications described below in Section 3.1, and detailed further in Section 4.1.

3.2 COUNTY GOLF CART AND UTILITY VEHICLE SPECIFICATIONS

- **Standard Golf Carts:** Shall include any two to four passenger, four wheeled, gas or electric powered golf cart, suitable tires, and industry standard features; i.e. beverage and scorecard holder, sweater basket, golf bag straps, tops, automotive type steering wheel, solid state control, foam padded seats with vinyl plastic coverings, rear fender scuff plates, safe and efficient tow bar system. All maintenance, parts, and repairs shall be included in the rate.

Examples may include, but are not limited to the following: EZGO TXT, Yamaha Drive, or Clubcar Precedent or DS model, or an approved equal quality golf cart, to be determined by the County.

- **Standard Utility Vehicles:** Shall include any two to four passenger, four wheeled, gas or electric powered utility vehicle, all terrain tires, and industry standard features; i.e. automotive type steering wheel, solid state control, foam padded seats with vinyl plastic covering and steel or aluminum load bed approximately 44" x 40" x 8", and a 1,200 lbs. minimum load capacity. All maintenance, parts, and repairs shall be included in the rate.

Examples may include, but are not limited to the following: Cushman Hauler 1200, Yamaha Adventure Two, or Clubcar Carryall 500, or an approved equal quality utility vehicle, to be determined by the County.

- **Heavy Duty Golf Carts and Heavy Duty Utility Vehicles:** Shall include any golf cart and/or utility vehicle with higher passenger and/or payload capacity than the standard golf cart and utility vehicles described above, with all terrain tires, and industry standard features. All maintenance, parts, and repairs shall be included in the rate.

Examples may include, but are not limited to the following: Columbia, Cushman, E-Z Go, Umax, or an approved equal quality golf cart or utility vehicle, to be determined by the County.

** The Awarded Bidder shall provide two (2) sets of keys for each golf cart and utility vehicle. Each key shall be identified by a tag number which corresponds the golf cart or utility vehicle **

3.3 BATTERIES AND CHARGERS

Electric golf carts and utility vehicles shall require replacement batteries if they discharge prematurely. The exact requirement (typically 36 golf course holes), will be determined by County staff on a cart/vehicle by cart/vehicle basis. If applicable, the solenoids shall be changed at the same time a battery is changed. Battery chargers must be compatible with existing electrical outlets at each facility to charge carts and vehicles. Battery chargers shall be serviced and maintained per the manufacturer's recommendations. Failure to replace batteries and/or repair or replace a malfunctioning battery charger within **three (3) business days** of notification, shall result in the Awarded Bidder owing the County a credit, retroactive to the first (1st) day of notification, equal to the daily rate of the golf cart or utility vehicle.

3.4 GOLF CART AND UTILITY VEHICLE REPORTING

Each golf cart and utility vehicle delivered shall be assigned a fleet number denoting the manufacturer's model or serial number, and plate; which shall be visibly affixed, for identification purposes. Some County departments may require golf carts and utility vehicles be delivered with custom four color logos, two per cart. The size, color and location of the logo

will be determined and provided by County staff. The Awarded Bidder may also be required to provide the County with reports, including but not limited to: number of carts and utility vehicles per County site, pricing, and usage.

3.5 DELIVERY

The Awarded Bidder will be provided a list of delivery locations and corresponding contact information via the post award contract roadmap. However, specific delivery instructions shall be detailed on the end user's purchase order. County staff will inspect each golf cart and/or utility vehicle prior to acceptance of delivery. The County reserves the right to return an order in whole or in part if the merchandise is not in compliance with the bid specifications. The Awarded Bidder will be required to pick-up the non-compliant golf carts and/or utility vehicles, and deliver their replacements within three (3) business days of notification, at no charge to the County. The Awarded Bidder will be responsible for any damages incurred during delivery and/or pick-ups.

After award, but prior to the issuance of a Purchase Order, a department representative will coordinate a meeting with the Awarded Bidder to solidify the logistics and timeline of the delivery.

3.6 SCHEDULED PREVENTATIVE MAINTENANCE, ON-DEMAND SERVICE, PARTS, AND REPAIRS

The county has six locations with large fleets at the five county golf courses, Zoo Miami, as well as various County Parks, having anywhere from 1 to 10 or more golf carts per location. This solicitation and resultant contract shall include all required components, equipment, labor, scheduled and/or preventative maintenance, on-demand service, parts, and/or repairs necessary to keep the golf carts and utility vehicles in good working condition, in accordance with the manufacturer's specifications, standards, recommended schedules, and/or operating manual and/or warranty, and/or as identified by County staff.

County staff shall advise the Awarded Bidder of any as-needed, On-Demand Service Repairs (those that are unscheduled) or Damage and/or Loss sustained, via any form of written notification, electronic, paper, etc. with a brief description of any problems or symptoms experienced. Contingent upon the problems and symptoms described and identified, the Awarded Bidder shall stock its service truck(s) with the necessary parts required in order to complete the repairs on-site, accordingly.

The Awarded Bidder shall complete all repairs for Preventative Maintenance, On-Demand Service, and Damage/Loss on-site. Should the repairs not be able to be completed on-site, the Awarded Bidder shall take the golf carts to their service facility, and repairs should be completed within **three (3) business days** of notification. All service and repairs must be completed with OEM parts or approved replacement aftermarket parts, in accordance with the manufacturer's warranty terms and conditions.

If the required service cannot be completed within the time allotted, the Awarded Bidder will be required to provide a loaner golf cart and/or utility vehicle of equal or better model, size, and capacity, at no additional cost to the County. Should the Awarded Bidder be unable to provide a loaner of equal or better model, size, and capacity, a credit equal to the daily rate (consistent with the days of the month applicable) shall be provided while the golf cart and/or utility vehicle is not in service.

The Awarded Bidder shall be responsible for all miscellaneous repairs and shall have service trucks adequately stocked in order to visit each location weekly and perform the required maintenance, upon coordination with County staff unless instructed otherwise.

Examples of the types of service that the Awarded Bidder will perform include but are not limited to:

3.7 WARRANTY

Warranties shall be made available to County staff, upon request, for each golf cart and utility vehicle provided. The Awarded Bidder shall fully guarantee each golf cart and utility vehicle against factory defects and workmanship, and shall correct any and all apparent and latent defects that may occur within the manufacturer’s standard warranty, at no expense to the County.

The Awarded Bidder shall provide, at its expense, all batteries, battery chargers, and all other parts necessary to keep the vehicles in working condition within the scope of the battery warranty, charger warranty and electrical equipment warranty. The Awarded Bidder and the County shall review warranties to determine a mutually agreeable schedule for the delivery of the aforementioned items to the County. Warrantied work must be completed within three (3) business days of the initial report and/or coordination with each facility manager to provide loaner cart(s)/vehicle(s) during the warranty service period. These loaner carts/vehicles shall be of equal or better model, size, and capacity and in safe, useable condition.

3.8 GLOBAL POSITIONING SYSTEM UNITS

The Awarded Bidder shall provide the GPS Units, software and related services to PROS which shall include the initial rental of 316 GPS Units for installation on golf carts used at Crandon, Country Club of Miami, and Palmetto golf courses. The County reserves the right to add or delete GPS Units upon notification to the Contractor of its desire to rent additional GPS Units for installation and use at the Course. Any GPS Units added shall be subject to the terms of the Agreement.

A. Services to be Provided

The Awarded Bidder’s personnel will map and provide graphics of the golf courses for screen display and configure the Solution devices to graphically depict the location of the golf carts throughout the facility. In addition, GPS unit will include geo-fencing functionality that will prohibit golf cart movement into restricted areas and can be remotely updated/modified via provided software from the clubhouse. In order to accomplish this, vendor will need access to the courses to take photographs and video of the course layout. After that is completed, graphics of the courses

can be accomplished in a two to three week period. If the County owns the existing graphics used on designated facility, then the vendor will use those graphics.

The installation and training process is anticipated to be completed within approximately one week, depending on factors such as weather and personnel availability for training. Since the system is web-based, the GPS units are ready to be used upon installation and activation of the accompanying software.

1. **Hardware and Software Requirements** – The County will provide a personal computer that runs Windows 7 Operating System (or higher) that has a reliable high-speed internet connection to operate the Solution and to view course activity. The Awarded Bidder shall provide a 42" LED to display the tracking system in each designated Proshop, at no additional rental cost to the County.
2. **Software Updates and Revisions** - Throughout the term of this contract, The Awarded Bidder shall provide tracking services related to the GPS units. The Awarded Bidder shall provide updates, modifications and revisions to the software. Such updates, modifications, and/or revisions shall be those that the Awarded Bidder may develop in the ordinary course of its business as improvements on, or corrections to, the existing tracking and reporting system software occur, at no cost to County.
3. **Training for the Proshop** – The Awarded Bidder shall work with County personnel for instruction on the use of the system pre-installation, during installation, and at reasonable times post-installation. The web-based system allows for monitoring and interaction with any authorized County personnel, using any secure internet connection. The system must also utilize an easy-to-use menu format that allows for a broad range of activities, such as changing carts from golfer mode to ranger mode, tracing daily cart activity, reviewing logged outgoing SMS messages, identifying plotted geo-fence violations, reviewing report information and handling advertising needs.

B. Operating Requirements for GPS Devices

The County shall provide the Awarded Bidder with access to the available high-speed internet access and hard connection portals suitable to support the installation and operation of the Solution at the facility. Examples of operational failures or service interruption may be due to loss of internet access, failure in hardware, or third party wiring and/or equipment not furnished by and under the control of the Awarded Bidder, including, but not limited to, failures or interruption due to acts or omissions of third party internet service providers. In addition, each golf cart onto which a GPS unit is mounted, must have a readily accessible and functionally steady power source that is compatible with the power specifications and requirements of the GPS unit.

C. Maintenance

The Awarded Bidder shall be responsible for any and all maintenance of the GPS units, in the event of failure or damage. The Awarded Bidder must replace any damaged or inoperable GPS units within three (3) business days. If the GPS unit is deemed irreparable, then the Awarded Bidder must provide a replacement unit within the three (3) business days aforementioned, at no cost to the County.

D. Spare Devices

The Awarded Bidder will provide the County with spare GPS units, so as to avoid operational interruptions, should a deployed unit malfunction and require to be sent back to the Awarded Bidder for repair and/or replacement.
