<u>SECTION 2</u> SPECIAL TERMS AND CONDITIONS

2.1 PURPOSE

The purpose of this solicitation is to establish a contract for the rental, installation and removal of security protection covering for window and doors for Miami-Dade County.

This solicitation will also establish a List of Prequalified Vendors (List) that will be used to solicit the purchase of hurricane shutters, installation /removal, and repairs for Miami-Dade County. Placement on the List is not a contract between the County and the Vendor, but an acknowledgement that the Vendor meets the qualifications as outlined throughout this solicitation. Vendor Submittals will continue to be accepted throughout the term of the solicitation for placement on such List.

2.2 **DEFINITIONS**

Invitation to Quote (ITQ) - Shall refer to the solicitation of quotes from the List of Prequalified Vendors for specific goods awarded based on lowest price or other quantifiable criteria.

List of Prequalified Vendors (List) – Shall refer to business entities/individuals determined by the County's Internal Services Department, Strategic Procurement Division, as meeting the minimum standards of business competence, financial ability, and/or product quality for placement on the List of Prequalified Vendors, and who may submit quotes/proposals, at the time of need.

Submittal - Shall refer to the forms submitted in response to Groups C, and D and of this solicitation.

Vendor- Shall refer to a business entity/individual responding Groups C, and D of this solicitation.

2.3 TERM OF CONTRACT

This contract shall commence on the first calendar day of the month succeeding approval of the contract by the Board of County Commissioners, or designee, unless otherwise stipulated in the Blanket Purchase Order issued by the Internal Services Department, Strategic Procurement Division. The contract shall expire on the last day of the five (5) year term.

2.4 METHOD OF AWARD

2.4.1 Group A- Protection Covering for Doors and Windows/Rental Non-Federal Funds

2.4.2 Group B- Protection Covering for Doors and Windows/Rental Federal Funds

These groups shall be used for the rental, installation and removal of security protection covering for windows and doors. Award for these groups will be made in the aggregate to the lowest priced, responsive, responsible Vendor.

Qualification for Group A and B

1. Vendor(s) shall provide two (2) current references on company's letterhead, signed to demonstrate that the Vendor is regularly engaged in the business of providing rental service for protection covering for windows and doors.

Vendor shall submit the required document(s) for Groups A and B with their submittal to be in compliance.

2.4.3 Group C- Purchase of Hurricane Shutters-Pregualification Pool

2.4.4 Group D- Installation, Removal and Repair of Hurricane Shutters-Pregualification Pool

These groups shall be used to prequalify Vendors for spot market quotation(s).

Qualification for Group C

- 1. Vendor(s) shall provide two (2) current references on company's letterhead, signed to demonstrate that the Vendor is regularly engaged in the business of providing hurricane shutters.
- Vendor(s) shall provide a letter from the product manufacturer(s) indicating that the Vendor is an authorized dealer, distributor, or reseller of their product(s). If the Vendor is the manufacturer of the product(s) listed in the solicitation, the Vendor shall provide a letter on the company's letterhead affirming that they are the manufacturer of the solicited product(s).

Qualification for Group D

- 1. Vendor(s) shall provide two (2) current references on company's letterhead, signed to demonstrate that the Vendor is regularly engaged in the business of installation and repairs of hurricane shutters.
- 2. Vendor shall provide one of the following license or certificate of Competency:
 - Miami Dade County Awnings & Storm Shutters Contractor
 - General Contractor
 - State of Florida General Contractor
 - Building Contractor
 - Metal Awning & Storm Shutter Contractor
 - Miscellaneous Metals Contractor
 - Specialty Structure Contractor
 - Specialty Glass & Glazing Contractor

Vendor shall provide all of the specified information for groups C and D, documents and attachments listed above with their Submittal as proof of compliance with the requirements of this RTQ. However, the County may, at its sole discretion and in its best interest, allow Vendors to complete, supplement or supply the required documents throughout the term of the RTQ. It shall be the sole right of the County to determine the number of Vendors which will be included in the Pool. During the term of the RTQ, the County reserves the right to add or delete Vendors as it deems necessary, and in its best interest.

a. INSURANCE

Insurance is **not** required in order to be prequalified under this RTQ. Insurance requirements will be detailed in the subsequent ITQ or WOPR.

b. SPOT MARKET QUOTES

Vendors in the Pool will be invited to participate in future spot market competition, as needed. The spot market competition will be in the form of an ITQ or WOPR that will include the specific goods and/or services required, and may include provisions, as applicable, such as:

- Small Business Enterprise (SBE) Measures
- Warranty Requirements
- Liquidated Damages Living Wage

For federally funded projects/programs, additional provisions may apply in accordance with the funding source. The following provisions from Section 1, General Terms and Conditions shall be exempted from such solicitations, as indicated in the ITQ or WOPR.

- Local Preferences
- User Access Program (UAP) Fee
- SBE Measures
- Local Certified Veteran Business Enterprise Preference
- First Source Hiring Referral Program
- SBE Prompt Payment Terms
- Office of Inspector General Fee

2.4.5 Qualification for All Groups

Vendors shall provide the contract information of a designated representative to provide the County with support and information concerning orders placed. Vendor shall provide the representative's name, phone number, and email address.

2.5 <u>INSURANCE REQUIREMENT IN SECTION 1, PARAGRAPH 1.21 TERMS AND CONDITION IS APPLICABLE</u> FOR GROUPS A AND B

2.6 PRICES FOR GROUP A and B

The initial contract prices resulting from this solicitation shall remain fixed and firm for no less than 12 months from the contract commencement date. It is the Awarded Vendor's responsibility to request any adjustment. The Awarded Vendors request for adjustment must be submitted to the County's Internal Services Department for review no less than 90 days prior to expiration of the then current contract year. The County may consider an adjustment based upon the PPI Other Heavy Machinery Rental and Leasing PCU532412532412 -200312 If no adjustment request is received from the awarded Vendor, the County will assume that the awarded Vendor has agreed that the next contract year will remain at the then current price.

The County reserves the right to reject any price adjustments submitted by the awarded Vendor or to negotiate lower pricing during the contract period based on market conditions or other factors that influence price. The County also reserves the right to apply the right to apply any reduction in pricing based on the downward movement of the applicable index.

SCOPE OF WORK/TECHNICAL SPECIFICATIONS

3.1 SCOPE OF WORK FOR GROUP A and B

The Vendor Shall provide covering that are constructed in a manner that allows it to fit over window screens, windows and doors which are placed outside the entry doors or windows to protect the units from vandalism.

3.2 SIZES

All doors, window screens and component parts must be quality controlled, inspected, and maintained by the Awarded Vendor. The products should allow adjustments to accommodate all size of window screens and door frames. Miami-Dade County vacant houses require that the semi-permanent covering be secured so they can only be removed and installed by the awarded Vendor using special tools for installation and/or removal as required.

3.3 WINDOWS

An assortment of fixing can be used to attach the covering to the window. The covering shall be made of steel material and the outside face of the covering shall be painted in a gloss metallic enamel finish so that paint, oils chalk, makers, and other graffiti can easily be removed.

3.4 DOORS

The security covering must be able to be affixed to the existing door structure. All coverings should be able to open from the inside providing easy egress in the case of an emergency exit. The door and doorway coverings shall be made of steel material and the outside face shall painted in a gloss metallic enamel finish so that paint oils, chalks, markers, and other graffiti can be easily removed.

3.5 LABOR

Installation and removal rate shall include all labor, materials, coverings and measurement for various window and door sizes. The installation rate is a one-time fee per window and door that shall be charged at the time of installation. Monthly rental rate shall be offered at a flat fee to include various window and door sizes.

3.6 SCOPE OF WORK FOR GROUPS C and D

The intent of this solicitation to identify and make available to the County, vendors capable of providing hurricane shutters, installation, removal, and repairs for multiple County departments, on an "as needed basis. Product approval is required by Miami-Dade County, notice of acceptance (NOA).

Quotes will entail various types and sizes, for various County facilities, and privately owned houses. Vendors are responsible for the completion of the project(s) which include all engineering, labor, supervision, materials, equipment, tools, and permits. And any incidentals, necessary to perform all operation for proper installation of the units.

3.7 GOODS/SERVICES TO BE PROVIDED FOR GROUPS C and D
