SECTION 2 - SPECIAL TERMS AND CONDITIONS

2.1 PURPOSE

The purpose of this solicitation is to establish a contract with an authorized Microsoft License Solution Partner for the purchase of Microsoft software licenses, and software assurance that aligns with the County's needs. The resultant contract will be awarded on behalf of the Information Technology Department as the program administrator for selected County departments.

2.2 TERM OF CONTRACT: THIRTY-SIX MONTHS

This contract shall commence on the first calendar day of the month succeeding approval of the contract by the Board of County Commissioners, or designee, unless otherwise stipulated in the Notice of Award Letter which is distributed by the County's Department of Procurement Management, and contingent upon the completion and submittal of all required bid documents. The contract shall expire on the last day of the last month of the contract term.

2.3 OPTION TO RENEW

Prior to, or upon completion of the initial term, the County, at its sole discretion, reserves the right to exercise the option to renew this contract for one (1) additional thirty-six month period.

2.4 METHOD OF AWARD

Award of this contract will be made to the responsive, responsible Bidder who submits an offer on all items listed in the solicitation and whose offer represents the lowest price when all items are added in the aggregate. If a Bidder fails to submit an offer on all items, its overall offer may be rejected. The County will award the total contract to a single Bidder.

2.5 PRICING

Prices shall remain firm and fixed for the term of the Contract, including any option or extension periods; however, the Contractor may offer incentive discounts to the County at any time during the Contract term, including any renewal or extension thereof.

2.6 METHOD OF PAYMENT

Payment for licenses and software assurance shall be based on the quoted price for the required products. Payment is due each year in advance at the anniversary date of the Enterprise Agreement Enrollment.

2.8 MICROSOFT LICENSING SOLUTIONS PARTNER - STATE AND LOCAL GOVERNMENT

As a part of their submission package, all Bidders must furnish proof of their Licensing Solutions Partner authorization from Microsoft. This proof may be provided as an official letter from Microsoft or any other official document provided by Microsoft that shows current status as an authorized Licensing Solutions Partner.

2.9 PURCHASE OF OTHER ITEMS NOT LISTED/ACCESS TO FULL MICROSOFT PRODUCT LIST

The County has listed items with Section 3.2 of this solicitation which are most frequently purchased by the County for the purposes of evaluation and selection of a Bidder to be recommended for award of the resultant contract. It is understood that the County may purchase any Microsoft product available under the Enterprise Agreement program or Select Agreement program or subsequent program introduced by Microsoft for the purchase of products. The County reserves the right to purchase any existing or future product from the full Microsoft Product List. Under these circumstances, a County representative will contact the awarded Bidder to obtain a price quote for such items. Any future purchases may be subject to pricing negotiations.

SECTION 3 - TECHNICAL SPECIFICATIONS

3.1 BACKGROUND

In May 2016, Miami-Dade County established an Enterprise Agreement No. X20-12056 with Microsoft for the use of Microsoft products across several county departments.
