## SECTION 2

#### SPECIAL TERMS AND CONDITIONS

#### 2.1 PURPOSE

The purpose of this solicitation is to establish a contract for the purchase of flight apparel in conjunction with County needs.

#### 2.2 TERM OF CONTRACT

This contract shall commence on the first calendar day of the month succeeding approval of the contract by the Board of County Commissioners, or designee, unless otherwise stipulated in the Blanket Purchase Order issued by the Internal Services Department (ISD), Strategic Procurement Division (SPD). The contract shall expire on the last day of the sixtieth (60<sup>th</sup>) month.

#### 2.3 METHOD OF AWARD

Award will be made to the lowest priced, responsive, responsible bidder in the aggregate who meets the qualifications listed below. In situations where a bidder wishes to provide the item or service at no cost to the County, enter zero (0) on the appropriate pricing line; do not leave the line blank.

a. Successful bidder shall be the manufacturer, authorized distributor, or authorized reseller of the item being bid. If a bidder is the manufacturer of the items proposed its submittal shall be accompanied with a signed letter on company letterhead so stating. Authorized distributors and/or resellers shall supply a letter from the product manufacturer acknowledging the bidder as authorized to sell their products.

If the awarded bidder fails to perform in accordance with the terms and conditions of the contract, The Bidder may be deemed in default of the contract. If the awarded Bidder defaults, the County shall have the right to negotiate with the next responsive, responsible Bidder.

#### 2.4 PRICES

The prices proposed by the successful bidder shall remain fixed for a period of no less than twelve (12) months after the commencement of the contract. After this period, the bidder may submit a request for price adjustment the County based on documented price adjustments by the product's manufacturer. Acceptable documentation for an adjustment may be an email or letter by the product Manufacturer to its distributors notifying them of an adjustment to the item(s) supplied. Said adjustment must be shown as a percentage or an actual dollar value. Requested adjustments greater than two percent on any items current value will be dis-allowed. The County reserves the right to negotiate lower pricing based on market conditions or other factors that influence price.

It is the bidder's responsibility to request any price adjustment under this provision. The bidder's request for adjustment must be submitted to the County's ISD, (SPD) for review no less than 90 days prior to expiration of the then current contract year.

The County reserves the right to reject any price adjustments submitted by the bidder.

## 2.5 EQUAL PRODUCTS

The mention of a particular manufacturer's brand name or style number in the specifications does not imply that this particular product is the only one that will be considered for purchase. This reference is intended solely to designate the s quality, style, color, and/or type of merchandise that will be acceptable. If an "equal" product is to be considered by the County in accordance with the pricing pages, the product shall be equal in style, color, quality and standards of performance to the item specified in the solicitation.

The determination as to whether any alternate product is or is not equal shall be made solely by Miami-Dade County and such determination shall be final and binding upon all bidders. Miami-Dade County reserves the right to request and review additional information and samples to make a determination.

Each 'equal' item must be clearly identified on the submittal pages(s) as to manufacturer and style number. Failure to provide this information with the offer may result in rejection of the offer.

## SAMPLES

Bidders may be required by Internal Services Department's (ISD), Strategic Procurement Division (SPD) to submit a sample of the goods to be supplied for evaluation by, and at no cost to the County. This sample will become property of the County, and may or may not be returned to the bidder at the County's option. If samples are required, the County will notify the bidder of such in writing and will specify the deadline for submission of the samples. Individual samples shall be clearly labeled with the bidder's name, bid number, bid title, manufacturer's name, brand name, and style number if applicable. Bidder may include a pre-paid return label which the County can use to return the sample in the event that the County chooses to. If the bidder fails to submit the samples, properly labeled, by the specified date stipulated in the notice, the County may not consider the bidder's proposal for that item. Any sample submitted shall create an express warranty that the whole of the goods and/or services to be provided by the bidder during the contract period shall conform to the sample submitted.

#### 2.6 DELIVERY

The successful bidder shall make deliveries of ordered items within thirty (30) calendar days after the date of the order with the exception of extended sizes which are defined as 3XL or its equivalent and larger which must be delivered within forty-five (45) calendar days of the order.

All deliveries shall be made in accordance with good commercial practice and all required delivery time frames shall be adhered to by the bidders; except in such cases where the delivery will be delayed due to acts of nature, strikes, or other causes beyond the control of the bidder. In these cases, the bidder shall notify the County of the delays in advance of the original delivery date so that a revised delivery schedule can be appropriately considered by the County.

Should the bidder(s) to whom the contract is awarded fail to deliver in the number of days stated above, the County reserves the right to cancel the order on a default basis. If the order is so terminated, it is hereby understood and agreed that the County has the authority to purchase the goods/services elsewhere and to charge the incumbent bidder with any re-procurement costs. If the bidder fails to honor these re-procurement costs, the County may terminate the contract for default. Repeated late delivery or failure to deliver complete order(s) may also result in default and contract termination.

In cases where uniform items are ordered for a particular individual, all items for that person shall be bagged or boxed collectively and labeled with the individual's name.

## 2.7 PURCHASE OF OTHER ITEMS

While the County has listed all major items within this solicitation which are utilized by County departments in conjunction with their operations, there may be similar items that must be purchased by the County during the term of this contract. Under these circumstances, a representative of the Internal Services Department's Procurement Management Section will contact the awarded bidder to obtain a price quote for the similar items. The County reserves the right to award these similar items to the awarded bidder, or to acquire the items through a separate solicitation.

#### 2.8 SUBSTITUTION OF ITEMS DURING TERM OF CONTRACT

Substitute brands or style number may be considered during the contract period for discontinued models. The bidder shall not deliver any substitute item as a replacement to an awarded brand or model without express written consent of Internal Services Department, Procurement Management Services Division prior to such delivery. Substitute items must be provided at the contract price and be of equal or better quality than the awarded item.

#### 2.9 INSURANCE REQUIREMENTS

The Insurance Requirements set forth in Section 1.0, Paragraph 1.22, General Terms and Conditions, are not applicable to this solicitation.
