TECHNICAL SPECIFICATIONS

3.1 SCOPE OF WORK

The purpose of this solicitation is to establish a contract for the purchase of canned and bottled beverages and boxed syrup products for beverage systems for various Miami-Dade County Departments on an as needed basis. Awarded Bidder shall furnish, install and service canned/bottled beverage vending machines/coolers/fountain equipment used to dispense the purchased products at no charge to the County during the contract period.

Unless otherwise noted, products to be provided shall be of nationally recognized and accepted brands, including but not limited to: Coca-Cola, Pepsi, Sprite, 7-Up, Diet Pepsi, Diet Coke, Diet Sprite, Diet 7-Up, Cherry Coke, Fanta, Fresca, Surge, Bargs Root Bear & Cream Soda, Minute Maid, Nestea, Seagrams Ginger Ale, Wild Cherry, Mountain Dew, Sunkist, Mug Root Bear, Dr. Pepper, Lipton Tea, Powerade, Gatorade, Dasani, Aquafina, and Evian.

3.2 PRODUCTS TO BE PROVIDED

1. CANNED ASSORTED BEVERAGES (packed 24/12 oz. cans per case)
