## SECTION 2

### ADDITIONAL/SPECIAL TERMS AND CONDITIONS

#### 2.1 PURPOSE

Miami-Dade Parks, Recreation & Open Spaces is seeking capable Bidders to remove and replace old golf course driving range netting with new ~~netting (and retractable~~ and non-retractable netting) at the following locations as specified below and in Section 3.

**Crandon Golf Course** – located at 6700 Crandon Boulevard, Key Biscayne, FL 33149 (must be retractable netting)

**Palmetto Golf Course** – located at 9300 SW 152<sup>nd</sup> Street, Miami, FL 33157 (must be retractable netting)

**County Club of Miami** – located at 6801 Miami Gardens Drive, Miami, FL 33015 (must be non-retractable netting)

Bidders shall incorporate into their pricing the cost of the new netting, installation, transportation, labor, and all miscellaneous supplies, cables, tools, and other equipment necessary for, or incidental to completing the services described in this solicitation without additional cost, surcharge or markup of any kind.

#### 2.2 TERM OF CONTRACT

This Contract shall commence on the first calendar day of the month succeeding approval of the Contract by the Board of County Commissioners, or designee, unless otherwise stipulated in the Purchase Order issued by the Internal Services Department, Strategic Procurement Division, and shall remain in effect until such time as the goods are delivered and/or services are completed, and accepted by the County's authorized representative and upon completion of the expressed and/or implied warranty periods.

#### 2.4 METHOD OF AWARD

Award of this contract shall be made to the lowest priced responsive, responsible Bidder in the aggregate who meets the qualification criteria listed below. If a Bidder fails to submit an offer for all items, its overall offer may be deemed non-responsive. If the Awarded Bidder defaults, the County shall have the right to negotiate with the next lowest priced responsive, responsible Bidder.

#### 2.5 REQUIREMENTS

Bidder(s) shall provide contact information to include name, title, email address and phone number for a designated company representative who can be contacted Mondays through Fridays from 8:00 a.m. to 5:00 p.m. to answer questions concerning the product or services provided.

Bidder(s) shall provide all of the specified information, documents and attachments listed above with their Submittal as proof of compliance with the requirements of this solicitation. However, the County may, at its sole discretion and in its best interest, allow Bidder(s) to complete, supplement or supply the required documents during the evaluation period.

#### 2.5 COMPLIANCE / REGULATIONS / SAFETY

##### A. Legal Requirement for Pollution Control

It is the intent of these specifications to comply with the Miami-Dade County Pollution Control Ordinance as stated in Chapter 24 of the Miami-Dade Code. This ordinance is made a part of these specifications by reference and may be obtained, if necessary, by the Bidder through Regulatory and Economic Resources, 33 SW 2nd Avenue, Miami, Florida 33130, Telephone (305) 372-6789.

#### B. Accident Prevention, Barricades and Safety

Bidders shall conduct the work in a manner, which shall not interfere with normal pedestrian traffic or adjacent sidewalks or vehicular traffic on adjacent streets, and shall not cause any annoyance to residents near the sites or users of the sites. Precautions shall be exercised at all times for the protection of persons and property. All Bidders performing services under this contract shall conform to all relevant OSHA, EPA, State and County regulations during the course of such effort. Any fines levied by the above mentioned authorities for failure to comply with these requirements shall be borne solely by the responsible Bidder. Barricades shall be provided by the Bidder when work is performed in areas traversed by persons, or when deemed necessary by the County.

Bidder agrees to perform all work in a manner that meets all accepted standards for safe practice, and to safely maintain and operate all the equipment used in the performance of this contract. The County, reserves the right to issue immediate restrain or cease and desist to a Bidder, when unsafe or harmful acts are observed or reported while performing under the contract. Hazardous conditions shall be immediately reported to the County.

Failure to comply with any of these requirements may result in immediate suspension of work.

#### C. Equipment

The Bidder's equipment shall be in proper working conditions, free from leaking fluids. All equipment shall include all safety devices, properly installed and maintained. If the County determines that the equipment is deficient in safety devices, the Bidder will be notified immediately. The Bidder shall remove the deficient equipment from services and replace it with working equipment

#### D. Identification

All personnel performing services under this solicitation must carry valid government issued photo identification such as a driver's license, and shall wear a nametag, t-shirt or company uniform that identifies the firm they are employed by while on County property.

### **2.5 WARRANTY**

In addition to the Warranty listed in Section 1, Paragraph 1.7, the following warranties applies: The Awarded Bidder shall warrant the netting for no less than ten (10) years, from the date of acceptance. Should the netting have any latent or manufacturers defect within this time period, a new panel shall be supplied and installed at no additional cost to the County. In addition, the original installation shall be warrantied for no less than three (3) years from the date of acceptance.

### **2.6 INSURANCE**

The following clause will replace Section 1.22.A.2 of the General Terms and Conditions:

2. Commercial General Liability Insurance on a comprehensive basis, in an amount not less than \$500,000 combined single limit per occurrence for bodily injury and property damage. Miami-Dade County must be shown as an additional insured with respect to this coverage.

**SECTION 3**  
**SCOPE OF WORK/TECHNICAL SPECIFICATIONS**

**3.1 SCOPE OF WORK**

The Awarded Bidder will be required to remove and properly dispose of existing netting at all three locations and install new and unused regular netting at Crandon Golf Course and new and unused retractable style netting at Palmetto Golf Course and Country Club of Miami.

**3.2 GOODS/SERVICES TO BE PROVIDED**

Bidders shall provide in Section 4 an all-inclusive price for the removal and disposal of old netting as well as furnishing and installation of new and unused netting and retractable netting at Crandon Golf Course, Palmetto Golf Course and Country Club of Miami Golf Course.

Bidders shall:

- Supply and install a Roxford Fordell GF86 Polyethylene Range Barrier Netting, or approved equivalent product, with poly rope border.
- Fastening of netting to 3/8" aircraft cable (top and bottom) using galvanized spring snap hooks at top and galvanized shackles, or approved similar, at bottom cable.
- Perform tightening of all cable and hardware where needed.
- Netting shall be installed with brace system using 5/16" aircraft cable (vinyl coated to 3/8")
- Netting panels shall be retractable at Palmetto Golf Course and Crandon Golf Course locations.

**3.3 NETTING REPLACEMENT DIMENSIONS**

**Crandon Golf at Key Biscayne (Retractable Netting)**

Right Side From Tee: Replace 300' of 50' wide sections of netting 40' in height.

Left Side From Tee: Replace 400' of 50' wide sections of netting 50' in height.

Rear: Replace 550' of 50' wide sections of netting 40' in height.

**Palmetto Golf Course (Retractable Netting)**

Right Side From Tee: Replace 750' of 50' wide sections of netting 60' in height.

Left Side From Tee: Replace 800' of 50' wide sections of netting 60' in height.

Rear: Replace 350' of 50' wide sections of netting 60' in height.

**Country Club of Miami (Non-Retractable)**

Right Side From Tee: Replace 150' of 50 wide sections of netting 100' in height

Right, Left, Rear: Re-attach and or replace approximately 1500' of vinyl coated aircraft cable.

**3.4 SCHEDULE AND HOURS OF OPERATION**

The Awarded Bidder shall start the work within thirty (30) working days from the receipt of the Purchase Order. The Awarded Bidder shall coordinate the schedule with the County prior to commencement of the work. The Awarded Bidder shall perform all services listed within this solicitation from Monday through Friday, 7:00 a.m.

to 6:00 p.m. Evenings, weekends and holidays work need to be preapproved by the County. The work shall be performed in such a manner as to cause the least interference with the normal operation of the facilities.

**3.5 INSPECTIONS**

Upon completion of installation, adjustment and testing by the Awarded Bidder, the County's designated representative shall perform an inspection and issue a written communication approving the netting and installation before Awarded Bidder permanently leaves the work site with its equipment and personnel.
