#### **RECOMMENDATION:**

This is a request for Small Business Development to proceed with the approval of the Recommendation of Contract Measures request for the Employee and Public Remote Parking Lot Shuttle Bus Service, RFP MDAD-11-16. MIA staff has evaluated the subject project and recommends an SBE-Selection Factor. The Prime will be providing 100% of Services. See Scope of Services and Minimum Qualifications for specialized services to be performed below. (Previous Worksheet issued 10/18/2006 attached).

The initial Term of the Management Agreement shall be five (5) years with an option of five (5) separate one year (1) term extensions at the sole discretion of the Department. The Estimated Fee of this project will be \$609,000.00 (Projected 5-year period).

#### INTRODUCTION/BACKGROUND:

Miami-Dade County (the "County"), as represented by the Miami-Dade Aviation Department ("MDAD"), requires the services of a qualified firm ("Operator") to enter into a Management Agreement to manage and operate the Employee and Public Remote Parking Lot Shuttle Bus Service ("Shuttle Bus") at Miami International Airport ("Airport").

The County is seeking an experienced and qualified Operator who will enhance the quality of services offered to the employees and the public at Miami International Airport. It is also the intention of the County to have the Shuttle Bus managed and operated in a premier, first class manner, providing prompt, safe and courteous service, and including the maintenance of County-owned buses.

#### **SCOPE OF SERVICES:**

The Board of County Commissioners, as well as the Miami Dade Aviation Department is committed to providing first class service to all Airport employees and the public. The Shuttle Bus Service is operated twenty-four (24) hours per day, seven (7) days a week. This service is provided for employees of the County, airlines and various companies conducting business at the Airport. The 2015/2016 operating schedule is comprised of forty three (43) employee shuttle shifts each day.

Shuttle bus service is also provided on an "as needed" basis to the public when the Economy Park and Ride overflow parking facility is utilized.

Shuttle bus service is also provided between Building 5-A and the main passenger terminal for MDAD employees and various companies conducting business at the airport. This service operates five (5) days a week, Monday through Friday, between the hours of 7:00 a.m. and 6:00 p.m. Two (2) employee shifts are used per day.

To support these various transportation systems, the Operator shall maintain thirty (30) County owned buses dedicated to the employee parking lot, two (2) van/mini-buses for the Building 5-A shuttle and Government Parking, and five (5) buses used by MDAD Airside personnel to provide airline transportation service for passengers on the airside portion of the airport.

The following are stated objectives to be achieved at Miami International Airport through the full implementation of the Employee and Public Remote-Parking Lot Shuttle Bus Service Management Agreement:

- 1. To manage, operate and maintain the buses in a first-class manner and condition and to provide such service as required or requested.
- 2. To provide additional drivers and service as required or requested.
- 3. To comply with all local, State and Federal laws.

### **MINIMUM QUALIFICATIONS:**

- 1. Proposer should have had not less than three (3) full years (36 full months) of experience in the ownership and operation of a transportation service business with gross revenues of not less than \$3,000,000 per year. The Proposer should demonstrate experience in the management, operation and maintenance of a high frequency transportation service primarily through the use of a fleet of buses, operated on a timely basis under peak traffic and peak customer service conditions, within an urban complex or within an airport in the scope and manner similar to that required in the Management Agreement. The Proposer shall demonstrate that it meets or exceeds this minimum qualification by providing the information on Appendix A.
- 2. If the Proposer is an individual or partnership, the individual and/or the partner, who shall be responsible for the operation of the Agreement, should have met the specified minimum qualifications. If the Proposer is a Joint Venture, then at least one (1) of the Joint Venture Partners should satisfy all of the foregoing Minimum Qualifications. A Proposer, whether a joint venture or otherwise, may proffer the experience of its corporate parent, sister, or subsidiary ("an affiliated company") in meeting these minimum qualifications. However, given the unique nature if individual corporate relationships. Proposers seeking to rely on the experience of an affiliated company should be advised that the Selection Committee shall have the discretion to determine what weight, if any, it wishes to give such proffered experience on a case-by-case basis, and may base such decision on the relationship between the Proposer and the affiliate, as evidenced by whatever documentation is provided in the proposal submission or otherwise presented at the request of the Selection Committee.
- 3. Must be authorized to do business in the State of Florida by the time of award.

4. Proposers who are less qualified than is suggested above may be considered for award. However, such Proposers may receive less points or no points from the Selection Committee, or may be found non-responsible.
