ORDER GRANTING MOTION FOR AGREED SANCTIONS

THIS CAUSE is before the Court upon the Motion for Sanctions, ECF No. [110] ("Motion"), filed by Plaintiff United States of America on April 30, 2018. Pursuant to the Court's February 9, 2018 Order, ECF No. [84], the United States requests that sanctions be imposed on Defendants Miami-Dade County, Miami-Dade County Board of County Commissioners, and Miami-Dade County Public Health Trust (collectively, "Defendants" or the "County") for non-compliance with the Court-ordered April 16, 2018 action steps contained in the Third Summary Action Plan, ECF No. [91]. *See* Joint Declaration Regarding Status of Compliance, ECF No. [108].

In the Motion, the United States seeks an order requiring the County to retain an expert or experts to provide regular on-site technical assistance in the areas of correctional medical and mental health care, and to assist the County in implementing the provisions of the Consent Agreement and current Summary Action Plan. The United States represents that it and the Independent Monitors will work with the County to identify the appropriate expert(s) to fill this role. The County does not oppose this relief.

Accordingly, the United States' Motion for Sanctions is **GRANTED** and it is

**ORDERED AND ADJUDGED** as follows:

1. As a result of Defendants' failure to comply with the April 16, 2018 action steps

in the Third Summary Action Plan, additional remedial relief is necessary.

2. **By Monday, June 18**, the County shall retain an appropriate subject matter expert

or experts who will provide regular on-site technical assistance in correctional medical and

mental health care and who will assist the County in implementing the provisions of the Consent

Agreement and the current Summary Action Plan. The County shall work with the United States

and the Independent Monitors to identify the appropriate expert(s) to fill the role.

3. The additional relief set forth in this order complies in all respects with the

provisions of 18 U.S.C. § 3626(a). The relief is narrowly drawn, extends no further than

necessary to correct violations of federal rights as alleged by the United States in its Complaint

and Findings Letter, is the least intrusive means necessary to correct these violations, and will

not have an adverse impact on public safety or the operation of the criminal justice system.

# Request for Emergency Declaration Court Ordered Retention of Correctional Medical and Mental Health Services Experts

Miami-Dade County entered into a Consent Agreement with the Department of Justice on May 22, 2013. Although Miami-Dade County has made progress towards reaching compliance with the 115 provisions, the Court has required specific deliverables be provided to the Monitors with time certain deadlines via a court order making meeting these deadlines imperative.

Miami-Dade County has now been court ordered to retain subject matter experts in correctional medical and mental health services to assist the County in developing the court-mandated deliverables within prescribed timelines and obtain compliance by June 2019. The attached court order specifically requires that the experts be retained by Monday, June 18, 2018 and that the experts be identified by the Monitors and the Department of Justice. The experts will provide routine on-site technical assistance in the areas of correctional medical and mental health to assist the County in implementing the provisions of the Consent Agreement and the current Summary Action Plan.

As such, Miami-Dade County is making an emergency declaration to retain the following experts no later than Friday, June 15, 2018 to meet court order mandate:

- Dr. Esmaeil Porsa earned his Medical Degree and a Master of Public Health Degree from the Texas Health Science Center Medical School and an Executive Master of Business Administration Degree in Healthcare Organization Leadership from the University of Texas at Dallas. Dr. Porsa has served as an Interim Chief Medical Officer for Parkland Hospital responsible for 1,500 staff members and 1,100 residents and as Medical Director of Correctional Health in the Parkland Hospital and Health System for over 10 years. Additional experience in correctional health includes serving as Associate Medical Director for University of Texas Health Science Center. Dr. Porsa has also obtained several relevant certifications that are integral to improving the delivery of medical services to the unique inmate population and therefore facilitate compliance with the Consent Agreement: National Commission on Correctional Health Care, Certified Correctional Healthcare Provider, Advanced 2015; National Commission on Correctional Health Care, Certified Correctional Healthcare Provider, Physician 2015 and 2005. Dr. Porsa is a published researcher focusing on management of tuberculosis as well as management of MRSA in the correctional health setting. He has also served as the medical monitor for Cook County and is extremely knowledgeable about how to obtain compliance with the Consent Agreement.

She has served as the Regional Clinical Director/Regional Comprehensive Quality Improvement Manager for the MHM Correctional Services and as the Mental Health Director and Staff Psychologist for the Massachusetts Correctional Institute. As a court appointed expert and contractor to evaluate mental health programs, Dr. Masotta has extensive experience to assist with Miami-Dade County compliance efforts with the Consent Agreement.
