The pool shall remain open for the term of the RTQ, enabling vendors to qualify at any time after the initial RTQ opening

date.

Reasons for Recommendation

An analysis of the factors contained in Implementing Order 3-41, as well as, an analysis of the project package indicates the appropriate measures as noted below for this project.

Group 1 - This group establishes a pre-qualified pool of Vendors to remain open for the term of the RTQ, enabling vendors to be added. SBE Set-Aside shal be applied where there are three (3) or more certified firms available in the established pre-qualified pool, the work order competition must be sheltered among those firms.

Bid Preference shall be applied when there are less than three (3) certified firms available in the establised pre-qualified pool.

Group 2 - This group establishes a 1st, 2nd, 3rd, 4th, 5th vendor list capable of providing services in the event of a request for Priority Services and Hurricane Recovery Response.

Bid Preference shall be applied at the time of award.

As of May 5, 2017 there are two (2) SBE Certified firms in the applicable commodity code.
