Purpose of the Purchase

Please describe your minimum requirements and the benefits of making the acquisition.

WASD is the legal authority and administrator for Miami-Dade's Cross Connection Control (CCC) Program. A Cross Connection is a connection or potential connection between any part of the potable water system to a non-potable or unknown water source, causing potential contamination to the water system.

The purpose of this bid waiver request is to acquire continued service of the Tokays Cross-Connection Control database system, provided by Tokay Software, Inc. The system is currently installed at ITD and has performed adequately for the 5 years of the current contract. During the current 5-year term, the customer base for testing gradually increased to the current 30,000 annual mark and this level is maintained in pricing throughout the proposed new 5-year term.

The proposed acquisition also assists WASD with its overall goal to protect the public water supply and public health.

Best Interest of the County / Uniqueness of Product

Tokay software is the sole source and sales agent for the Tokays application, application support, user training and on-line hosting services utilized by WASD for CCC program administration.

Tokay Software hosts the website where private testers enter test results online. Tests are electronically loaded into the Tokays application. Hundreds of hours of manual data entry are eliminated by Tokay's

online testing service. Tokays is the only Microsoft SQL application dedicated to CCC & Backflow Prevention program administration.

Market Research

Please describe your market research and the results thereof. This should include a description of other, similar sources or products available in the market if any and why they are not acceptable.

A competitive proposal was received on 1/11/2018, from XC2 Software, LLC. XC2 is a leading competitor for Tokay, but a change in systems will also cause a change in hardware at ITD and an increase in overall costs.

XC2's Year1 Installation & License costs would range from \$33,000 - \$35,000. Tokay set up costs were about \$25,000 in its initial year.

XC2's annual Maintenance Fees (after the first year) are about \$6,400 (plus unknown annual escalations) versus \$3,900 (Year2) to \$5,000 (Year5) for Tokay's proposed Maintenance costs.

Customer's Test Fees for XC2 and Tokay are the same at \$1 per test or \$30,000 annually.

A 5-year contract with XC2 is approximately \$210,000 versus \$171,435 with Tokay (5-year savings about \$39,000).

Proposed Actions

WASD proposes the continued use of the Tokays product, as provided by Tokay Software, Inc. since it is sufficiently functional and optimally priced, while marketplace developments will be monitored routinely for more efficient and competitive systems.
