SECTION 2

SPECIAL TERMS AND CONDITIONS

2.1 <u>PURPOSE</u>

The purpose of this solicitation is to establish a contract for the acquisition of Airlink Multi-Network Mobile Vehicle Routers, associated components, licenses, and maintenance and support services. The equipment is required by the Miami-Dade Fire Rescue (MDFR) department to outfit their frontline suppression and rescue vehicles. The vehicle routers will deliver secure, persistent, wireless wide area networking which is required for the following tasks:

- Connect onboard computer to the Computer Aided Dispatch System (CAD)
- Connect ACETECH telemetry device to the network. This system is used for real-time notification of vehicle diagnostics to the MDFR Mobile Equipment Bureau
- Provide network communications for incident reporting system tablets.
- Provide FirstNet service, and support priority and pre-emption services

2.2 TERM OF CONTRACT

This contract shall commence on the first calendar day of the month succeeding approval of the contract by the Board of County Commissioners, or designee, unless otherwise stipulated in the Blanket Purchase Order issued by the Internal Services Department, Strategic Procurement Division. The contract shall expire on the last day of the twenty-fourth month.

2.3 OPTION TO RENEW

The County shall have the option to renew this contract for one (1) additional two (2) year periods. Continuation of the contract beyond the initial period, and any option subsequently exercised, is a County prerogative, and not a right of the Bidder. The County reserves the right to negotiate lower pricing for the additional term(s) based on market research information or other factors that influence price.

2.4 METHOD OF AWARD

Award of this contract will be made to the responsive, responsible vendor who submits an offer on all items listed in the solicitation and whose offer represents the lowest price when all items are added in the aggregate. If a vendor fails to submit an offer on all items, its overall offer may be rejected. The County will award the total contract to a single vendor.

2.5 PRICES

If the Bidder is awarded a contract under this solicitation, the prices proposed by the Bidder shall remain fixed and firm during the term of the contract.

2.6 <u>CERTIFICATIONS</u>

In order to be considered for award of this solicitation, Bidder(s) must be an authorized Sierra Wireless Partner/Distributor. Bidder(s) are advised that along with their bid submission, an authorization letter from Sierra

Wireless must be included confirming the current status of the firm as being an authorized Sierra Wireless Partner/Distributor.

2.7 <u>"EQUAL" PRODUCT CANNOT BE CONSIDERED</u>

The specific items listed in Section 3.2, "Equipment to be Provided", are the only products that will be accepted under this solicitation because these items are formally approved/authorized by the Miami-Dade Fire Rescue department. "Equal" products shall not be considered.

2.8 PURCHASE OF OTHER ITEMS NOT LISTED WITHIN THIS SOLICITATION BASED ON PRICE QUOTES

While the County has listed all major items within this solicitation which are utilized by County departments in conjunction with their operations, there may be similar items that must be purchased by the County during the term of this contract. Under these circumstances, a County representative will contact the primary vendor to obtain a price quote for the similar items.

3.4 SUPPORT SERVICES TO BE PROVIDED

To support the equipment being solicited, MDFR requires that Bidders provide Platinum Extended Support with hosted Airlink Mobility Manager. Platinum Support shall include the following:

3.4.1 <u>Extended Technical Support</u>

- Priority telephone and email support within 2 hours during normal office hours.
- Emergency telephone support within 1 hour, 24 hours per day, 365 days per year.
- Access to online Knowledge Base.
