**SECTION 2 – SPECIAL TERMS AND CONDITIONS**

**2.1 PURPOSE**

The purpose of this solicitation is to establish a contract for the purchase of public safety/work uniforms as listed and specified herein. Eligible vendor(s) must be pre-qualified under RTQ-00124 prior to the closing date of this ITQ. Submittals received from non-eligible Bidders will not be evaluated.

**2.2 METHOD OF AWARD**

Award of this ITQ will be made on an item by item basis to the lowest priced, responsive, responsible Bidder. An 'item' is defined as the total of all prices for the required sizes. Failure to provide a price for a required size may result in the bid for that item being rejected. In situations where a Bidder wishes to provide the item or service at no cost to the County, enter zero (0) on the appropriate pricing line; do not leave the line blank. Bidder(s) shall provide prices for additional services as described in Paragraphs 3.8 & 3.9. All bids received for additional services will be awarded to each Bidder.

**2.3 CONTRACT TERM**

This Contract shall commence on the first calendar day of the month succeeding approval of the contract by the Board of County Commissioners, or designee, unless otherwise stipulated in the Purchase Order issued by the County. The term of this Contract shall be for twenty-four (24) months.

The County reserves the right to exercise its option to extend this Contract for up to one hundred eighty (180) days beyond the current contract term, as per Section 1.6, Contract Extension.

**2.4 PRICES**

The pricing provided by the Awarded Bidder(s) shall remain fixed for a period of no less than twelve (12) months after the commencement of the contract. After this period, the Awarded Bidder(s) may submit a price adjustment to the County based on a manufacturer's written notification to the supplier of price increases. The manufacturer's notification shall be submitted to the County's Internal Services Department, Strategic Procurement Division for review. Adjustment request greater than five percent (5%) on any item will be dis-allowed. The County reserves the right to negotiate lower pricing based on market research information or other factors that influence price.

**It is the Awarded Bidder(s)' responsibility to request any pricing adjustment under this provision.** The Awarded Bidder(s)' request for adjustment must be submitted to the County's Internal Services Department, Strategic Procurement Division for review no more than ninety (90) days or less than forty-five (45) days prior to expiration of the current contract period.

**2.5 DELIVERY**

Delivery for items sized XS - 2XL is required within thirty (30) calendar days after receipt of an order. Extended sizes defined as 3XL – 5XL and larger must be delivered within forty-five (45) calendar days after receipt of an order. Special orders, defined as items specially made by a manufacturer for the use of Miami-Dade County must be delivered in the timeframe agreed upon by the County and Awarded Bidder(s). Special order items are shown as such in Section 4, Pricing.

Awarded items become the property of Miami-Dade County when County insignia is applied; uniform items are not to be sold or released to the public. Contract items may be picked up by County employees with proper identification.

## **2.6 INDIVIDUAL PACKAGING**

In cases where uniform items are ordered for a particular individual, all items for that individual shall be bagged or boxed collectively and labeled with the individual's name, and order prior to delivery.

## **2.7 RETURNS**

Within sixty (60) days of receipt by the County, unused and unaltered items incorrectly ordered or delivered shall be accepted by the Awarded Bidder(s) for full credit to the County with no restocking fee. Unaltered items are defined as articles as produced by the manufacturer for its inventory (i.e. pants un-hemmed or hemmed as they are for industry standard, shirts without embroidery, patches, or alteration to sleeve length, etc.).

## **2.8 PRODUCTS**

### **A. EQUALS**

The mention of a particular manufacturer's brand name or style number in Section 3, Technical Specifications, does not imply that the particular brand name or style number is the only one that will be considered for purchase. This reference is intended solely to designate the style, color, type or quality of merchandise that will be acceptable. If an equal product is to be considered by the County in accordance with Section 3, Technical Specifications, the product shall be equal in style, color, quality, and standards of performance to the item specified in the solicitation. Equal products must be clearly identified by Bidders in Section 4, Pricing, and must include manufacturer and style number. Failure to provide this information may result in rejection of the offer.

The determination as to whether an alternate product is or is not equal shall be made solely by Miami-Dade County and such determination shall be final and binding upon all Bidders. Miami-Dade County reserves the right to request and review additional information and samples to make a determination.

### **B. SAMPLES**

Bidders may be required to submit a sample of equal products proposed for evaluation by, and at no cost to, the County. If samples are required, the County will notify the Bidder of such in writing and will specify the deadline for submission. Each individual sample shall be clearly labeled with the Bidder's name, bid number, bid title, line item number, manufacturer's name, brand name, and style number.

If the Bidder fails to submit the samples as noted above, the County will not consider the Bidder's proposal for those items. Any samples submitted shall create an express warranty that the whole of the goods to be provided by the Bidder during the contract period shall conform to the samples submitted. The samples will become property of the County, and may or may not be returned to the Bidder at the County's sole discretion. Bidder will be notified if samples are available for return at which time the Bidder shall provide a pre-paid return label. Unclaimed samples shall be disposed of by the County as it deems fit.

## **2.9 PURCHASE OF OTHER ITEMS**

While the County has listed items within this solicitation which are utilized by County departments in conjunction with their operations, there may be similar items that must be purchased during the term of this Contract. Under these circumstances, a representative of the Internal Services Department, Strategic Procurement Division, will contact all Awarded Bidder(s) to obtain a price quote. Award of these items will be made as described in Paragraph 2.2, Method of Award. In cases where a product has been awarded and additional sizes, or services are required by the County, the Bidder(s) awarded the item(s) shall be solicited for the new requirement. The County retains the right to reject any quote received and purchase the item through other means.

## **2.10 SUBSTITUTION OF ITEMS**

Substitute brands and/or styles may be considered during the Contract period for awarded items discontinued by the manufacturer. The Awarded Bidder(s) shall not deliver any substitute item as a replacement to an awarded item without

express written consent of the Internal Services Department, Strategic Procurement Division, prior to such delivery. Substitute items must be provided at the Contract price and be of equal or better quality than the awarded item.

## **2.11 CONTRACT MEASURES**

A Small Business Enterprises (SBE) Bid Preference measure is applicable to this solicitation. Refer to Sections 2-8.1.1.1.1 and 2-8.1.1.1.2 of the Miami-Dade County Code for guidance.

The SBE Business Enterprise must be certified by bid submission deadline and at Contract award to remain eligible for the preference.

## **2.12 INSURANCE REQUIREMENTS**

The following supersedes the insurance coverage listed in Section 1, Paragraph 1.22 (B); all other information remains the same:

The Bidder shall furnish to Miami-Dade County, Certificate of Insurance which indicates that insurance coverage has been obtained which meets the requirements as outlined below:

- A. Worker's Compensation Insurance for all employees of the Contractor as required by Florida Statute 440.
- B. Commercial General Liability Insurance in an amount not less than \$300,000 per occurrence, and \$600,000 in the aggregate. Miami-Dade County must be shown as an additional insured with respect to this coverage.
- C. Automobile Liability Insurance covering all owned, non-owned and hired vehicles used in connection with the work, in an amount not less than \$300,000 combined single limit per occurrence for bodily injury and property damage.

# **SECTION 3 - TECHNICAL SPECIFICATIONS**

## **3.1 SCOPE OF WORK**

Awarded Bidder(s) shall provide various styles and types of items which comprise an approved Miami-Dade County uniform. The Bidder's price shall include the screening of the Miami-Dade County logo (See Section 3.6.2) and the ordering department's name below the hook on all apparel.

Although item specifications may refer to a color, prices bid will apply to all the colors offered by the manufacturer for the item bid. Bidders must provide at a minimum the color specified. Bidders are reminded that all estimated usage figures are best guess estimates, there are no assurances that an item awarded will be ordered. Unless required by the County, minimum order quantities shall not be allowed.

## **3.2 SERVICES TO BE PROVIDED**

Specifications that refer to the following County departments may require department identifiers other than or in addition to the Miami-Dade County logo (hook) and department name.

- A. Miami-Dade Police Department (MDPD)

MDPD uses numerous patches on their uniforms, prices shall include the sewing on of County provided patches. Fabric for taupe shirts is Delta 150 or Swift Galey 2077 tropical weave, pants fabric is Burlington-Raeford, color D056 Brown.

- B. Miami-Dade Fire Rescue (MDFR)

MDFR assigns its uniform items an internal identifying/stock number, orders may be placed by this department using this stock number. Some items specifications include instructions for the placement of images on the product, these images are identified in Paragraph 3.6.12, pricing for MDFR items are inclusive of all required embroidery, silk screening and patches.

C. Miami-Dade Corrections and Rehabilitation Department (MDCR)

MDCR uses numerous patches on their uniforms, prices shall include the sewing on of County provided patches. Item 58 will be purchased by MDCR employees using personal funds.

D. Department of Solid Waste Management (DSWM)

DSWM uses both the County logo and County provided patches on uniforms.

E. PORT MIAMI

Port Miami uses both the County logo and the PortMiami logo on their uniforms.

F. AVIATION

Aviation uses both the County logo and the Aviation logo on their uniforms. The department name "Miami International Airport" embroidered along the bottom of the combined logos (see Image 2). Left sleeve has both MIA logo and County logo one on top of the other.

### **3.3 COUNTY EMBLEMS AND PATCHES**

Embroidery, silk screening and sewing of patches shall be priced as an additional service in accordance with Section 3, Paragraph 3.8. Prices offered by Bidders for additional services shall be at fair market value. Paragraph 3.6 provides specifications for some of the images required. All patches will be provided by the County. Patches shall be sewn with matching color thread around the full perimeter of the patch in a manner that the patch will be permanently affixed to the uniform.

### **3.4 MEASUREMENTS, ALTERATIONS, HEMMING AND CUSTOMIZATIONS**

Hemming and alterations shall be priced as an additional service in accordance with Section 3, Paragraph 3.8. Hemming, alterations, and customizations shall include the following:

- Hemming of pants and skirts;
- The proper fitting of blazers and coats; and
- Alterations to suit individual requirements and/or specifications

Awarded Bidder(s) shall be solely responsible for securing all necessary employee measurements. By accepting an order without obtaining the employee's measurements the Awarded Bidder(s) is accepting the liability of incorrect sizing and possible returns.

Awarded Bidder(s) shall further be responsible for all necessary alterations to ensure a proper fit.

Only minor alterations may be required. Alterations that might change the style of the garment or which will deplete all of the allowance in seams provided shall be considered major alterations. Custom tailoring of uniform items to an individual's taste may be offered at open market pricing.
