Reasons for Recommendation

This Request to Qualify will establish a pre-qualified pool of vendors to participate in future spot market purchases to provide acrylic and polymer sheets and adhesives as needed.

SBE Set-Aside for projects up to \$100K: Where there are three (3) or more certified SBE firms available in an established pre-qualification pool, the work order competition must be sheltered among those firms.

Bid Preference for projects up to \$100K: 10% Bid Preference to should be applied to certified SBE firms when a set-aside is not attainable.

All projects valued over \$100K should be submitted to SBD for review and determination of the applicable SBE measure.
