Requisition/Project Title: Financial and P3 Advisory Services

Description: Miami-Dade County has initiated a procurement process to design, build, finance, operate, and maintain a Civil and Probate Courthouse to replace the existing courthouse located at 73 W. Flagler Street. To assist the County in this P3 Project, the County awarded a competitive contract, RFP-00199, to KPMG LLP to advise the County on the Courthouse Project along with other P3 projects that were approved by the Board in 2016. KPMG advised the County on the project until April 2018, however, it was determined that KPMG had to be removed from the project due to an inadvertent breach of confidential information. The Board has directed the Administration to expedite the procurement of the Courthouse Project and advising services are required for the remainder of the project to achieve the successful completion of the project. To continue expediting the Courthouse Project as directed by the Board, it was determined that a bid-waiver contract to the second-ranked proposer from RFP-00199 was necessary to ensure that the County is adequately protected for this transaction.
