SECTION 2

SPECIAL TERMS AND CONDITIONS

2.1 PURPOSE

This Request to Qualify (RTQ) will establish a Prequalified Pool of Vendors (Pool) that will be used to solicit for the purchase of plumbing equipment, supplies, materials, tools and other related items for Miami-Dade County (County). Placement in the Pool is **not** a contract between the County and the Vendor, but an acknowledgement that the Vendor meets the qualifications as outlined throughout this RTQ. Vendor Submittals are accepted throughout the term of the RTQ for placement in such Pool.

2.2 DEFINITIONS

Invitation to Quote (ITQ) – Shall refer to the solicitation of quotes from the Pool for specific goods and/or services; and awarded based on lowest price, or other quantifiable criteria.

Prequalified Pool of Vendors (Pool) – Shall refer to business entities/individuals determined by the County's Internal Services Department, Strategic Procurement Division, as meeting the minimum standards of business competence, financial ability, and/or product quality for placement in the Pool, and which may submit quote or proposal, at the time of need.

Vendor - Shall refer to a business entity/individual responding to this RTQ.

Submittal - Shall refer to all information, attachments and forms submitted in response to this RTQ.

Work Order Proposal Request (WOPR) – Shall refer to the solicitation of offers from the Prequalified Pool of Vendors for specific goods and/or services; and evaluated and awarded based on best value.

2.3 TERM

The Pool shall be established on the first calendar day of the month succeeding approval by the Board of County Commissioners, or designee, unless otherwise stipulated in the Blanket Purchase Order issued by the Internal Services Department, Strategic Procurement Division. The Pool shall expire on the last day of the sixtieth (60) month.

2.4 QUALIFICATION CRITERIA

Vendor shall meet the following criteria to be considered for placement in the Pool and for participation in future competitions:

- Vendor(s) shall provide contact information to include: Company's main phone number, company's website, if any; name of primary contact person, direct phone number and email address. Additionally, Vendor shall provide contact information of a designated representative who can be contacted Monday through Friday from 8:00 a.m. to 5:00 p.m. (local time) to provide the County with support and information concerning orders placed and to receive and respond to future spot market competitions.
- 2. Vendor(s) shall demonstrate experience pertaining to the relevant sale of products requested in this RTQ. As evidence, Vendor(s) are required to provide two (2) current references from existing customers that are currently receiving or have recently received from the bidder products described in this solicitation. The references must include the contact name, company's name, address and telephone number. The County shall be able to ascertain from these references to its satisfaction that the Vendor has sufficient experience and expertise in providing the products listed in Section 3.2 or similar types of products.

3. Vendor(s) shall be an authorized dealer or distributor for the brand(s) submitted. Vendor shall submit documentation showing compliance with this requirement in the form of a manufacturer's letter, an executed agreement, designation on the manufacturer's website, or other verifiable documentation to ascertain to the County's satisfaction that the vendor is an authorized dealer or distributor of the manufacture. If Vendor is a plumbing equipment manufacturer, etc., a letter shall be provided on company's letterhead indicating brand names manufactured.

Vendor shall provide all of the specified information, documents and attachments listed above with their Submittal as proof of compliance with the requirements of this RTQ. However, the County may, at its sole discretion and in its best interest, allow Vendors to complete, supplement or supply the required documents throughout the term of the RTQ. 2.5 INSURANCE
