**SECTION 2 - SPECIAL TERMS AND CONDITIONS****2.1 PURPOSE**

The purpose of this solicitation is to establish a contract for the purchase of animal food in conjunction with the County's needs on a needed basis.

**2.2 TERM OF CONTRACT**

This contract shall commence on the first calendar day of the month succeeding approval of the contract by the Board of County Commissioners, or designee, unless otherwise stipulated in the Notice of Award Letter which is distributed by the County's Procurement Management Division, and contingent upon the completion and submittal of all required bid documents. The contract shall expire on the last day of the sixty (60) month period.

**2.3 METHOD OF AWARD****2.3.1 Group A: By Item**

Award(s) will be made to the lowest priced responsive, responsible vendors on an item-by-item basis at the sole option of the County.

**2.3.2 Group B: Pre-Qualification for Spot Market Quotes**

All vendors awarded under group A shall be deemed pre-qualified under group B. Entry into the pre-qualification pool is not a contract between Miami-Dade County and any member of the pool, but rather is an acknowledgement that the pool member satisfies the pre-qualification criteria set forth below for membership in the pool. Pre-qualified vendors will be invited to participate in future spot market competitions. The pool shall remain open for the term of the contract, enabling vendors to qualify at any time after the initial bid opening date.

**2.3.3. Qualification Criteria**

Three current references of existing customer other than Miami-Dade County. The references listed must be customers that are currently receiving, or have recently received from the bidder the same types of goods specified in this solicitation. These references shall ascertain to the County's satisfaction that the bidder has sufficient experience and expertise in supplying animal food.

Provide an email address or facsimile number that is available twenty-four (24) hours per day. The bidder's facility must be staffed by representatives who can be contacted Monday through Friday from 8:00 AM to 5:00 PM.

**2.4 PRICES**

The prices resultant from this solicitation shall prevail for the term of the contract, except as hereby noted. The County will consider yearly price adjustments, to be effective on the contract's annual anniversary date, based on the Manufacturers Price Increase. It is the bidders' responsibility to request any pricing adjustment under this provision. Requests for price adjustment shall be submitted to the Internal Services Department Procurement Management Division ninety (90) days prior to the contract's anniversary date.

Requests for price adjustment must clearly substantiate the requested increase. The County reserves the right to negotiate prices, approve or disapprove price adjustments, or cancel its contract with the bidder, in its best interest.

## **2.5 DELIVERY**

- 2.5.1 The vendor shall make deliveries in accordance with schedules provided by the County department(s). All deliveries shall be made in accordance with good commercial practice and all required delivery timeframes shall be adhered to by the vendor(s); except in such cases where the delivery will be delayed due to acts of nature, strikes, or other causes beyond the control of the vendor. In these cases, the vendor shall notify the County of the delays in advance of the original delivery date so that a revised delivery schedule can be appropriately considered by the County.
- 2.5.2 Certain County employees may be authorized in writing to pick-up materials under this contract. Bidders shall require presentation of this written authorization. The bidder shall maintain a copy of the authorization. If the bidder is in doubt about any aspect of material pick-up, vendor shall contact the appropriate user department to confirm the authorization.
- 2.5.3 Should the vendor(s) to whom the item(s) is awarded fail to deliver in the number of days agreed, the County reserves the right to cancel the contract on a default basis. If the contract is so terminated, it is hereby understood and agreed that the County has the authority to purchase the goods elsewhere and to charge the incumbent vendor with any re-procurement costs. If the vendor fails to honor these re-procurement costs, the County may terminate the contract for default.
- 2.5.4 The successful vendor shall enclose a complete packing slip or delivery ticket with any items to be delivered in conjunction with this bid solicitation. The packing slip shall be attached to the shipping carton(s) which contain the items and shall be made available to the County's authorized representative during delivery. The packing slip or delivery ticket shall include, at a minimum, the following information: purchase order number; date of order; a complete listing of items being delivered; and back-order quantities and estimated delivery of back-orders if applicable.
- 2.5.5 The County shall not allow any late deliveries attributed to product back order situations under this contract. Accordingly, the vendor is required to deliver all items to the County within the time specified in this solicitation and resultant contract and/or as agreed with the user department; and no grace period on account of back order situations shall be honored, unless written authorization is issued by the user department, and a new delivery date is mutually established. In the event that the vendor fails to deliver the products within the time specified, the County reserves the right to cancel the order, seek the items from another vendor, and charge the incumbent vendor for any re-procurement costs. If the vendor fails to honor these re-procurement costs, the County may terminate the contract for default.

## **2.6 EQUAL PRODUCT**

- 2.6.1 The manufacturer's names, or brand names, in this solicitation are being used for the sole purpose of establishing the minimum requirement of level of quality, standard of performance, and design and this is in no way intended to prohibit the offer of other manufacturer's items of equal material and performance. An "equal" product shall be equal in quality and standards of performance to the product specified in the solicitation. The County shall be sole judge of equality, based on its best interest, and its decision in this regard shall be final. Items labeled "No Substitute" on the Submission Form are the only products that will be accepted under this solicitation.

2.6.2 Bidder must submit the following documentation to enable County evaluation of "equal" products:

1. Product Information Sheets
2. Product Samples Upon Specific Request
3. Product labels

If an "equal" product may be considered by the County in accordance with the Bid/Proposal Submission Form, the unit shall be equal in quality and standards of performance to the item specified in the solicitation. Where an "or equal" item is offered, and product information sheets are required, the initial offer must be accompanied with two (2) complete sets of product information sheets (such as factory specifications, standard manufacturer information sheets, catalogues, and brochures), and if required, two (2) copies of performance test results of the unit offered as an equal. Also for product information submittals, all supporting documentation submitted by the Offeror must in total meet the required specifications set forth in this solicitation. Where the standard product literature submitted with the offer provides information that does not comply with the specifications, the Offeror shall state, in an official letter on corporate letterhead as part of their initial offer, the differences between the item they are specifically offering, and the equipment described by the standard product literature, to substantiate compliance to all of the specifications set forth in this solicitation. In such cases, any offer submitted with standard product literature but without the letter explaining compliance will result in the rejection of the offer for not meeting the solicitation specifications.

If samples of all "or equal" items bid are required for evaluation, such items are to be provided at no cost to the County, and should be submitted with the initial offer, or at the time of specific request. Failure to meet this requirement may result in your offer being rejected.

For "equal" products to be evaluated based on submission of product labels, the initial offer should be accompanied with labels indicating the specification and ingredients for each "or equal" item offered. Failure to meet this requirement may result in your offer being rejected.

The County shall be sole judge of equality, based on the best interests of the County, and its decision in this regard shall be final.

## **2.7 PURCHASE OF OTHER ITEMS**

While the County has listed all major items within this solicitation which are utilized by the county departments in conjunction with their operations, there may be similar items that must be purchased by the County during the term of this contract. Under these circumstances, the County representative may obtain price quotes from bidders under Group B.

## **2.8 RANDOM TESTING OF SAMPLES**

Samples of delivered items may be randomly selected and tested for compliance with specifications. If it is found that a delivered product does not conform to the specifications, the County shall require replacement within a reasonable length of time and may cancel its contract with the bidder for default.

**2.9 ACCEPTANCE OF PRODUCT AND DAMAGE GOODS**

2.9.1 The product(s) to be provided hereunder shall be delivered to the County, and maintained if applicable to the contract, in full compliance with the specifications and requirements set forth in this contract. If a vendor-provided product is determined to not meet the specifications and requirements of this contract, either prior to acceptance or upon initial inspection, the item will be returned, at vendor expense, to the vendor. At the County's own option, the vendor shall either provide a direct replacement for the item, or provide a full credit for the returned item. The vendor shall not assess any additional charge(s) for any conforming action taken by the County under this clause.

2.9.2 The vendor shall promptly replace any damaged goods. The vendor shall be responsible for filing, processing, and collecting all damage claims against the shipper.

**2.10 SHELF LIFE OF STOCK**

The successful vendor(s) shall supply the County with fresh stock only and shall ensure that items with a limited shelf life are inspected and certified fresh by the vendor prior to shipment to the County.
