### Reasons for Recommendation

#### SMALL BUSINESS ENTERPRISE - CONSTRUCTION (SBE-Con)

An analysis of the factors contained in Section VI. C. of Implementing Order 3-22 indicates that a 5% Small Business Enterprise – Construction (SBE-Con) subcontractor goal is appropriate for the trade of All Other Specialty Trade Contractors (Asbestos Abatement, Demolition, Contaminated Soil Remediation, Mold Remediation and Indoor Air Quality Work), Asbestos removal contractors, Remediation and cleanup of contaminated buildings, mine sites, soil, or ground water and Site remediation services.

#### SMALL BUSINESS ENTERPRISE - GOODS (SBE/G)

An analysis of the factors contained in section VIII. B. of Implementing Order 3-41& Ordinance 14-41 indicates that a 0.37% is appropriate for the SBE/G portion of this contract in the Commodity Codes; First Aid And Safety Equipment And Supplies (Except Nuclear And Welding), Janitorial Supplies (General Line), Office Supplies (General).

#### SMALL BUSINESS ENTERPRISE - SERVICES (SBE/S)

An analysis of the factors contained in section VIII. B. of Implementing Order 3-41& Ordinance 14-41 indicates that a 0.63% is appropriate for the SBE/S portion of this contract in the Commodity Code, Industrial Equipment Rental Or Lease.


