SECTION 2

SPECIAL TERMS AND CONDITIONS

2.1 PURPOSE

This Request to Qualify (RTQ) will establish a Pool of Prequalified Vendors that will be used to solicit Refractory Fire Bricks and related material (anchors, harwaco bonding, shot tech, accelerator, wore fibers, etc) for Miami-Dade County (County). Placement in the pool is **not** a contract between the County and the Vendor, but an acknowledgement that the Vendor meets the qualifications as outlined throughout this RTQ. Vendor Submittals will continue to be accepted throughout the term of the RTQ for placement in such pool.

2.2 DEFINITIONS

Invitation to Quote (ITQ) – Shall refer to the solicitation of quotes from the Pool of Prequalified Vendors for specific- goods; and awarded based on lowest price, or other quantifiable criteria.

Pool of Prequalified Vendors (Pool) – Shall refer to business entities/individuals determined by the County's Internal Services Department, Strategic Procurement Division, as meeting the minimum standards of business competence, financial ability, and/or product quality for placement on the Pool of Prequalified Vendors, and who may submit quotes, at the time of need.

Vendor – Shall refer to a business entity/individual responding to this RTQ.

Submittal - Shall refer to the forms submitted in response to this RTQ.

2.3 TERM

This Pool shall be established on the first calendar day of the month succeeding approval by the Board of County Commissioners, or designee, unless otherwise stipulated in the Blanket Purchase Order issued by the Internal Services Department, Strategic Procurement Division. The initial prequalification pool shall prevail for a three (3) year period from the initial effective date. The Pool shall expire on the last day of the three (3) year term.

2.4 QUALIFICATION CRITERIA

Vendors shall meet the following criteria to be considered for placement on the pool; and for participation in future competitions.

- A. Vendor(s) shall provide the contact information of a designated representative to provide the County with support and information concerning orders placed and to receive future spot market competitions. Vendor shall provide the representative's name, phone number, and email address.
- B. Vendor(s) shall provide a minimum of two (2) current references on company letterhead, signed to demonstrate that the Vendor is regularly engaged in the business of providing refractory fire bricks and materials. The County shall be able to ascertain from these references to its satisfaction that the Vendor has sufficient experience and expertise providing refractory fire bricks and materials.
- C. Vendor(s) shall be an agent, dealer, reseller or distributor of Harbison-Walker Refractory and shall provide verifiable proof of the ability to furnish refractory fire bricks and materials manufactured by Harbison-Walker to determine their qualification. This proof may be in one of the following forms:

- **Manufacturer Letter** – The manufacturer letter(s) shall be on manufacturer's letterhead and shall be dated within six (6) months of the vendors' bid submittal and it shall be signed by an authorized manufacturer's representative.
- **Manufacturer Website** – The manufacturer's website shall designate the vendor as the agent, dealer, reseller or distributor of the OEM.
- **Manufacturer / Vendor Agreement** – The vendor shall provide a copy the current agreement between the manufacturer and vendor designating the vendor as the agent, dealer, reseller or distributor.

Vendors shall provide all of the specified information, documents and attachments pooled above with their Submittal as proof of compliance with the requirements of this RTQ. However, the County may, at its sole discretion and in its best interest, allow Vendors to complete, supplement or supply the required documents throughout the term of the RTQ. It shall be the sole right of the County to determine the number of Vendors who will be included in the Pool. During the term of the RTQ, the County reserves the right to add or delete Vendors as it deems necessary and in its best interest.

2.5 INSURANCE

Insurance is not required in order to be prequalified under this RTQ. Insurance requirements may be detailed in the subsequent ITQ.

2.6 SPOT MARKET QUOTES

Vendors on the Pool will be invited to participate in spot market competitions, as needed. The spot market competitions will be in the form of an ITQ that will include the specific goods and/or services required, and may include provisions, as applicable, such as:

- Small Business Measures
- Warranty Requirements
- Liquidated Damages
- Living Wage
