
## 3.1 SCOPE OF WORK

This Request to Qualify (RTQ) will establish a Pre-qualified Pool of Vendors to furnish ice and related items for Miami-Dade County on an as needed basis. Items to be provided include but are not limited to the following:

- Block Ice
- Crushed or Snow Ice
- Cube Ice
