

## FINAL PUBLIC NOTICE

The Federal Emergency Management Agency (FEMA) has received the subgrant application for Miami-Dade County's CAHS Disability Service and Independent Living repairs to the sewer pipe due to damages in Hurricane Irma (DR-4337-FL PW 07626). Pursuant to Executive Order 11988 and 44 CFR Part 9.12, final notice is hereby given of FEMA's intent to provide funding for this project under the Public Assistance (PA) Program.

An initial disaster-wide Public Notice was published October 06, 2017 for Hurricane Irma. Comments and other information received were fully evaluated by FEMA along with evaluation of social, economic, environmental, and safety considerations. This notice serves as a project-specific final notice for FEMA's funding action located within the floodplain.

Funding for the proposed project will be conditional upon compliance with all applicable federal, tribal, state and local laws, regulations, floodplain standards, permit requirements and conditions. This action complies with the National Flood Insurance Program (NFIP) requirements.

- Floodplain:** Project is located in the AE Zone per Miami-Dade County FIRM Panel #12086C0312L dated 09/11/2009.
- Proposed Work and Purpose:** Miami-Dade County removed and replaced 20 lineal feet of 16-inch diameter TJ, cement lined, ductile iron sewer pipe at the CAHS Disability Service and Independent Living facility. The tree that caused the damage was moved to a swale area adjacent to the facility for the County to pick up. No hazard mitigation project was proposed.
- Project Alternatives:** An alternative location for this project is not practicable because the sewer pipe must be within the proximity of the Disability Service and Independent Living facility to serve its purpose, and relocation would not be feasible. A no action alternative is also not feasible because the facility would continue to be vulnerable to further damages and pose safety hazards to the occupants and visitors.
