# Business recycling is easy.

Three easy steps to comply with **mandatory recycling**



Commercial recycling is the law. Business and property owners are required to provide a recycling program.

## Step 1: Establish a recycling program that includes at least **three** items from this list:

- High grade office paper
- Mixed paper
- Corrugated cardboard
- Wood
- Scrap production metals
- Steel
- Glass
- Textiles
- Plastics
- Aluminum

## Step 2: Arrange to have your recyclables picked up by a Miami-Dade County permitted hauler.

- Start with your current waste hauler. Many offer recycling services.
- Or call a private recycling vendor. Check the business section of the telephone directory for companies that provide recycling collection services.

## Step 3: Design your recycling program to fit your needs.

- Appoint a capable and enthusiastic person as your recycling coordinator.
- Decide which materials to recycle based on the list above.
- Identify the types of containers you'll need, how many and where you should place them.
- Design a system for collecting recyclables and moving them to a central location for hauling.
- Educate employees on your new program and the benefits of recycling.

### Did you know?

*Commercial establishments in Miami-Dade County produce an estimated 1.7 million tons of waste each year! That's more than half of our community's solid waste, and much of it is recyclable.*

### Are there other options to comply with recycling?

Yes. Because not all businesses are alike, you can request to be approved for a "modified" recycling program.

There are four modified program options:

- Collect your recyclables and take them directly to a recycler for sale and processing.
- Substitute recyclable materials not included on our list, as long as your suggested materials comprise a greater portion of your waste than any of the materials listed.
- Recycle less than the three materials required, as long as the recyclable materials you don't recycle comprise less than 5 percent of your waste.
- Hire an authorized private hauler to collect recyclable materials at your establishment and separate them at a permitted materials recovery facility.

### Are there penalties for not recycling?

The County will provide technical assistance to help your business comply with the County's recycling law. Businesses that don't comply could be fined. Fines range from \$300 to \$950 based on the square footage of the commercial establishment and can be assessed daily until compliance is met.
