Submit W-4 Withholding Information - Job Aid



DESCRIPTION

This job aid is for all employees. Employees are responsible for self-service functions. The purpose of this job aid is to help employees perform the necessary steps to submit the W-4 withholding information. The process flow is as follows:

	 Step 3: Claim Dependents (if applicable) To claim tax credits for dependents, follow the instructions provided in the View Instructions icon to verify that this is applicable to you. If so, please provide the appropriate values in the value boxes. Only dollar amounts are accepted. 		
4.	Step 3: Claim Dependents To qualify for the child tax credit, the child must be under age 17 as of December 31, must be your dependent who generally lives with you for more than half the year, and must have the required social security number. You may be able to claim a credit for other dependents for whom a child tax credit can't be claimed, such as an older child or a qualifying relative. For additional eligibility requirements for these credits, see Pub. 972, Child Tax Credit and Credit for Other Dependents. You can also include other tax credits in this step, such as education tax credits and the foreign tax credit. To do so, add an estimate of the amount for the year to your credits for dependents and enter the total amount in Step 3. Including these credits will increase your paycheck and reduce the amount of any refund you
