

Easy Card Giveaway - 100 Monthly Passes

1. Agreement to Rules: By participating, the Contestant (“You”) agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. In addition, You agree to accept the decisions of Miami-Dade County Transportation and Public Works as final and binding as it relates to the content of this Campaign.

2. Campaign Period: Entries will be accepted online starting on [08/08/2016, 10am EST] and ending [08/12/2016, 11:59pm EST].

4. How to Enter: The Campaign must be entered by submitting a comment entry to a the Miami-Dade Transit Facebook page. The entry must fulfill all Campaign requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Miami-Dade County Transportation and Public Works. You may enter only once. You must provide the information requested.
