#### LUXURY LIMOUSINE SEDAN FOR-HIRE LICENSE APPLICATION

#### **INFORMATION SHEET**

**Note:** New luxury sedan licenses may only be issued to existing Miami-Dade County luxury sedan license holders or to new limousine operators located in Miami-Dade County. <u>Applicants who are not current Miami-Dade County</u> <u>luxury sedan license holders must have a place of business in Miami-Dade County.</u>

The Department of Transportation and Public Works (DTPW) defines a luxury limousine sedan or luxury sedan as a non-metered, sedan or sport utility vehicle (SUV) that has a Manufacture Suggested Retail Price (MSRP) of \$45,000.00 or higher and has not had the manufacturer wheelbase modified. In addition, SUVs shall not exceed 136" wheelbase or have a seating capacity greater than (9) nine passengers. Vehicles with a lower MSRP will be reviewed on a case-by-case basis.

#### **Application Attachments:**

- Complete and notarize the application form. Type or print neatly.
- All questions must be answered completely by applicant. Do not leave blanks. Note N/A if not applicable.
- **Submit as attachment #1** copy of the Articles of Incorporation or fictitious name registration, where applicable.
- **Submit as attachment 2** Miami-Dade County Local Business Tax receipt for the business which may be obtained at the Tax Collectors office located at **200 NW 2**<sup>nd</sup> **Avenue, Miami, FL 33128.**
- The fee is \$350.00 per application and \$25.00 Florida Department of Law Enforcement (FDLE) criminal background check per each applicant, individual, partner, officer, director, or shareholder. Note that you may apply for one or multiple licenses; however, the number of licenses may not be increased once the application is approved, and a new application must be submitted. Checks or Money Orders must be made payable to Miami Dade County. We also accept all major credit cards (Visa Master Card or Amex). Application fees are non-refundable.

#### Additional Information:

Upon review if the application is approved a compliance letter and instruction sheet will be mailed. The compliance letter will disclose license fee amount to be paid for the current license year. Annual license fee is \$350.00 per license and is not included in the application fee.
