



FOR-HIRE TRANSPORTATION SERVICES FEE SCHEDULE

The following regulatory and application fees are non-refundable, unless otherwise stated, and are separate from any occupational license fee that may be applicable. Cash is not accepted. Fees can be paid by check, money order or cashiers check made payable to the Miami-Dade County Department of Transportation and Public Works. If renewing in person, the renewal fee can be paid by credit card (Mastercard, Visa or American Express).

I. AMBULANCE

The following fees pertain to Advanced Life Support and/or Basic Life Support ground or air ambulance transport services. The triennial expiration date for private ambulance Certificates is December 31 of each third calendar year.

A. Initial application fee for a Certificate of Public Convenience and Necessity by a private provider.	\$1,500.00

Certificates are valid for one year. The Non-Emergency (NE) Certificate of Transportation cycle runs from April 1 to March 31 of the following year. Certificate renewal forms are mailed to the operator a minimum of 60 days prior to the expiration of the certificate. STS certificates are not transferable. Initial Certificate and operating permit fees shall be prorated according to the number of months remaining between the month of the date of issuance and the month of annual renewal.

Certificates are valid for one year. The Passenger Motor Carrier (PMC) Certificate of Transportation cycle runs from April 1 to March 31 of the following year. Certificate renewal forms are mailed to the operator a minimum of 60 days prior to the expiration of the certificate. Transfers of PMC certificates must be approved by the Board of County Commissioners. Initial Certificate and operating permit fees shall be prorated according to the number of months remaining between the month of the date of issuance and the month of annual renewal.

Certificates are valid for one year. The Special Transportation Services (STS) Certificate of Transportation cycle runs from April 1 to March 31 of the following year. Certificate renewal forms are mailed to the operator a minimum of 60 days prior to the expiration of the certificate. STS certificates are not transferable. Initial Certificate and Operating Permit fees shall be prorated according to the number of months remaining between the month of the date of the issuance and month of annual renewal.
