REBATE AGREEMENT — RELEASE OF LIABILITY

The rebate amount will be made payable to the applicant or credited to their Water & Sewer account. The Miami-Dade Water and Sewer Department (WASD) may deny any application that does not meet all Program requirements. Requirements can be obtained by reading the *Program Terms and Conditions for Participation* on the back of this form. **WASD reserves the right to alter this Program at any time.** Rebates shall be issued on a first-come, first-served basis provided Program funding exists. WASD reserves the right to modify Program funding at its discretion, and no person applying for a rebate shall be guaranteed or entitled to receive a rebate. WASD does not partner with any entity to promote the Program or endorse any product associated with the Program or that would qualify for a rebate. The Applicant agrees to allow WASD to inspect all fixture(s)/installation(s) as a condition for obtaining a rebate under this Program. WASD does not endorse or recommend any high efficiency item approved for a rebate. WASD is not responsible for the quality of the item purchased and does not warrant or guarantee any product, nor any fixture comprising a component in any fixture or its installation. WASD does not represent that any particular fixture is suitable for installation at a given location and disclaims all warranties of suitability or fitness for any purpose. WASD does not warrant or guarantee lower water bills as a result of participating in the Program. WASD is not responsible for any damage that may occur to applicant's property as a result of removing the old fixture or installing the new fixture under this Program. The Applicant acknowledges that installation of a fixture may require a building permit and the retention of a licensed contractor. Nothing herein shall prevent or stop Miami-Dade County from enforcing the terms of any portion of the Code of Miami-Dade County, the Florida Building Code and any permit issued thereto, or any other rule, state, ordinance, or requirement, and no rebate shall be provided for work performed in contravention of any of the preceding. The Applicant is solely responsible for permitting and retention of a licensed contractor to perform the installation work.

The Applicant agrees to hold harmless WASD, its directors, officers, and employees from and against all loss, damage, expense, and liability resulting from or otherwise relating to the purchase, installation, use, or removal of a fixture. I certify that I have read, understand, and agree to the terms and conditions of this rebate Program, including the *Program Terms and Conditions for Participation* on section below.

Program Terms and Conditions for Participation

- 1. For applications with a Miami-Dade Water & Sewer Department (WASD) water account a credit in the amount of qualifying rebate(s) will be applied to your account, otherwise a check will be sent.
- 2. **High Efficiency Toilet** (HET) A maximum of fifty (50) toilet rebates per Miami-Dade County property folio are provided per fiscal year (October 1-September 30). For rebate amount visit www.miamidade.gov/waterconservation.or.call.3-1-1. *Only EPA WaterSense certified models are eligible NO substitutions will be accepted under this Program.*

- 3. Properties must be constructed prior to 1996
- 4. High Efficiency Showerhead(s) (HES)/ Faucet(s) (HEF)
 - a. A maximum of fifty (50) WaterSense certified faucet and showerhead rebates each per Miami-Dade County property folio are provided per fiscal year (October 1-September 30).
 - b. Instead of a rebate, ICI properties can request a free Large Volume Distribution of high efficiency showerheads. Visit www.miamidade.gov/waterconservation for more information.
- 5. **High Efficiency Flushometer-Valve Toilets** Water Sense labeled flushometer-valve toilets, use no more than 1.28 gpf *Only EPA Water-Sense certified models are eligible- NO substitutions will be accepted under this Program.*
- 6. **Urinals** Water Sense labeled flushing urinals use no more than 0.5 gpf and comply with existing standards for flushing urinals. *Only EPA Water-Sense certified models are eligible No substitutions will be accepted under this program.*
- 7. Rebates shall be provided on a first-come, first-served basis until Program funds are expended. This Program is subject to available funds and WASD reserves the right to alter Program funding or Program requirements at any time without notice. WASD does not guarantee that Program funding shall be sufficient that all persons submitting applications shall receive a rebate. Visit www.miamidade.gov/waterconservation for the most current information on rebate qualifications and funding.
- 8. Sales receipt(s) for new fixture(s) must be submitted with the rebate application. NOTE: SALES RECEIPT MUST INCLUDE METHOD OF PAYMENT (i.e. credit card, PayPal, cancelled check, bank statement, etc.).
- 9. Must include list of units that have been retrofitted. For each unit, Include the unit number, number of bathrooms per unit, and type and number of fixtures installed per unit.
- 10. Incomplete applications and those without a sales receipt will be returned to the applicant. All receipts must show the itemized price for each item and/or service for which the rebate(s) is/are being requested and the receipt must show that the items/services were paid for in full.
- 11. Qualifying fixtures <u>must</u> be installed in a manner which complies with all applicable laws, ordinances and building codes before submitting the rebate.
- 12. Rebate amount applies only to purchase of a qualifying high efficiency WaterSense certified fixture(s). *Installation Costs are not reimbursable.*
- 13. WASD reserves the right to inspect fixtures prior to issuing a rebate.
- 14. This rebate does not cover new construction.
- 15. WASD is not responsible for rebate checks lost or delayed in the mail. Rebates shall be deemed to be received by the applicant upon mailing by WASD.
